

The conference convened key representatives from sport and the development sector in Oceania, to share best practice of what works, present the latest evidence-based approaches, and create a shared agenda for action to strength Pacific sport as we take the next steps towards defining and leading Brisbane 2032 legacies in and for the Pacific Islands.

The Brisbane 2032 Games taking place in Oceania gives the OTU an important anchor to connect our agenda for transforming Pacific sport with every milestone along the road – from Paris to Los Angeles in 2028 and then on to Brisbane come 2032 recognizing that we also have critical milestones in our region including the Pacific Games and other significant events.

## 6. Challenges

#### **GOVERNANCE**

Governance in many of our MNAs face several unique challenges, which can vary by country but generally include the following:

All of our MNAs are islands, many of which are remote and have limited infrastructure. This geographic diversity can complicate coordination, logistics, and communication for MNAs to govern efficiently let alone try to host regular cost-effective events.

Many countries have limited financial resources, which simply affect the ability to develop sports programs, facilities, and governance structures. Domestic funding for MNAs relies on government support, sponsorships, and donations, which is inconsistent.

Inadequate sports training facilities, and transportation networks, can hinder the growth and development of all sports in our region, particularly true in smaller or less-developed nations. Our MNAs have a rich tapestry of cultures and traditions. While this diversity is a strength, it can also pose challenges in terms of governance and representation, as different groups may have varying priorities and approaches to sports.

Political instability in many of our MNAs impact the governance of our organisations. Changes in government can lead to shifts in priorities and funding, affecting sports development initiatives. Capacity building is difficult due to the lack of trained personnel and expertise in sports administration and governance. This limits the effectiveness of organizations and the ability to implement best practices in management, coaching, and athlete development.

Athlete development and their access to quality coaching, training, and competition opportunities can be challenging, particularly in less populated areas due to insufficient funding which is crucial for fostering talent and ensuring success on regional and international stages.

The understanding, promotion and support for gender equality remains a significant issue in sports governance and participation across the Oceania region. Increasing the representation of women in leadership roles and ensuring equal opportunities for female athletes are ongoing challenges.

Environmental challenges are occurring more often with recent Tsunamis, earth quates etc which severely impact sports infrastructure and opportunities, events can be canceled or relocated due to natural disasters, posing additional governance challenges. As sports become increasingly globalized, most countries in Oceania struggle to compete with larger nations that have more resources and infrastructure to support their athletes, coaches and officials.

Addressing these challenges requires cohesive efforts among governments, sporting organizations, and communities to build more robust governance structures and develop sports sustainably in the region.

#### **PARA**

Any Paralympic sport in the Oceania region face several challenges, similar to those in other parts of the world, but with specific contextual factors that impact their development. Limited funding and resources for many of our MNAs struggle with financial constraints that limit the availability of funding for para-sport programs, athlete development, and infrastructure.

Little or no access to training facilities and sports specific equipment, which are often not designed with inclusivity in mind, can pose significant barriers to participation in para-sports. Awareness and acceptance for para-athletes and the capabilities of athletes with disabilities with cultural attitudes towards disability can also affect participation and interest in para-sport.

Coaching and training with knowledge and experience in para-sport is a major challenge and this hinders the effective development of athletes and coaches. Transportation and accessibility in many areas, especially in remote communities, transportation to training and competition venues is a major challenge.

With almost no access for athletes with a disability to health and rehabilitation services impacts the ability of athletes to recover from injuries and maintain their physical health when in training. Competitive opportunities are limited for competition at local, national, and international levels due to coast affect the development of athletes. Smaller countries will struggle to offer even the simplest in training for athletes to gain experience.

Cultural barriers, cultural stigma or misconceptions around disability can hinder participation. Addressing these challenges requires concerted efforts from national sports organizations, governments, communities, and international bodies to promote inclusivity and create an enabling environment for para-sport in the region.

### **EDUCATION / DEVELOPMENT**

Providing education and development in Taekwondo in the Oceania region presents several challenges.

Again, all of our MNAs consists of many islands and remote communities, which can make access to quality sporting facilities and coaching difficult. The vast distances between islands can hinder the transportation of resources and personnel as costs are extremely high to event complete the simplest task

All MNAs lack the financial resources to support comprehensive sports education programs. Limited funding affects the ability to adequately educate and develop administrators, athletes, coaches and officials alike. For smaller MNAs (most of ours) to actually be in a position to afford the expensive sports specific equipment necessary for effective training of athletes, coaches and officials is almost impossible.

Poor infrastructure, such as inadequate training facilities and transport networks, restrict the development of Taekwondo programs. Identifying and nurturing talent can be challenging, particularly in remote areas where limited pathways for youth to transition into elite sports programs.

Many communities in Oceania face health challenges, including high rates of obesity and related diseases. This can affect participation in sports and overall physical fitness, making it harder to develop competitive athletes. There may be a shortage of qualified coaches and volunteers to support local sports initiatives. Training programs for coaches may be limited, impacting the quality of instruction.

With the ongoing support from World TT and other strategic partners including the Oceania National Olympic Committees, Pacific Games Council, Olympic Sports Federations of Oceania, together with WT development support, the OTU will continue to provide further development and training programs throughout 2025 for its MNAs and their members.

Future development objectives include but are not limited to the following:

- Accredit further WT IRs,
- Accredit further Level 1 & 2 coaches with the region
- Identify, develop and have athletes participate yearly in WT promoted and sanctioned.
- Conduct face to face WT coaching, referee and technical courses for MNA's and their members in 2025.
