This article also applied to the case that the referee makes an error in counting, and the judges may raise a different opinion to the referee while the referee counts "Seht (three)" or "Neht (four)".

# (Guideline for officiating)

...Then, the referee may declare "Shi-gan (time)" to stop the contest and gather the judges to ask for a statements. After discussion, the referee must publicize the resolution. However, this shall not be accepted when one of the coaches has requested for an instant video replay review. In this case, the referee shall only accept the request from the coach.

- In case there is an objection to a referee judgment, an official delegate of the team must submit an application for re-evaluation of

decision (protest application) together with the prescribed fee to the Board of Arbitration within 10 minutes after pertinent contest. Deliberation of re-evaluation shall be carried out excluding those members with the same nationality as that of either contestant concerned, or resolution on deliberation shall be made by majority. The members of the Board of Arbitration may summon the refereeing officials for confirmation of events. The resolution made by the Board of Arbitration will be final and no further means of appeal will be applied. Deliberation procedures are as follows:

- a. After reviewing the protest application, the contest of the protest must be arranged according to the criterion of "Acceptable" or "Unacceptable".
- b. If necessary, the Board can hear opinions from the referee or judges.
- c. If necessary, the Board can review the material evidence of the decision, such as the written or visual recorded data.
- d. After deliberation, the Board shall hold the secret ballot to determine a majority decision.
- e. The Chairman will make a report documenting the outcome of the deliberation and shall make this outcome publicly known.

#### f. <u>Treatment of the decision</u>

- A. Errors in determining the match results, mistakes in calculating the match score or misidentifying a contestant shall result in the decision being reversed.
- B. Error in application of the rules:
  When it is determined by the Board
  that the referee made a clear error
  in applying the Competition Rules,
  the outcome of the error shall be
  corrected and the referee shall be
  punished.
- C. Errors in factual judgment: When the Board decides that there was a clear error in judging the facts such as impact of striking, severity of action or conduct, intention, timing of an act in relation to a declaration or area, the decision shall not be changed and the officials seen to have made the error shall be punished.

#### Summary of taekwondo competition

#### A. Disciplines and medal events

The competitions will be held in accordance with the Kyorugi Competition Rules of the World Taekwondo Federation (WTF).

- 1. Discipline(s) / Event(s)
  - 1.1 Taekwondo (sparring) Competitions (1 discipline and 8 events)
  - 1.2 Taekwondo Demonstration Performances (non-competition)\*

#### 2. Weight Categories

The number of weight categories at WTF World Taekwondo Championships is eight (8) per male and female division respectively. However, we propose to conduct four (4) weight categories per male and female respectively (Olympic weight categories) as follows considering limited number of athlete quota per sport.

Men's division	Women's division
Under 58kg	Under 49kg
Under 68kg	Under 57kg
Under 80kg	Under 67kg
Over 80kg	Over 67kg

#### **B.** Competition Format

1. System of Competition

The competition will use a single elimination tournament without repechage.

#### 2. Duration of Competition

The duration of the contest shall be three rounds of two minutes each, with one-minute rest between rounds. In case of a tie score after the completion of the  $3^{rd}$  round, a  $4^{th}$  round of two minutes will be conducted as the sudden death overtime round, after one-minute rest following the  $3^{rd}$  round.

#### 3. Valid Points

- 3.1 Legal scoring area
  - 3.1.1 Body: The blue or red colored area of the body protector

<sup>\*</sup>Demonstration is non-competition performance containing various programs of different taekwondo aspects such as breaking, form and self-defense skills, etc. Demonstration performances may take place before finals and/or during lunch break, etc. Detailed demonstration performance event program should be discussed afterwards.

- 3.1.2 Head: The area above collar bone
- 3.2 Points shall be awarded when permitted techniques are delivered accurately and powerfully to the legal scoring area
- 3.3 The valid points are divided as follows
  - 3.3.1 One (1) point for attack on body protector
  - 3.3.2 Two (2) points for a valid turning kick to the trunk protector
  - 3.3.3 Three (3) points for a successful attack to the face
- 3.4 Points can be scored by judges or electronic protector system (to be determined by the WTF in due time)

#### 4. Penalties

- 4.1 Penalties are divided into "Kyong-go (warning penalty)" and "Gam-jeom (deduction penalty)".
- 4.2 Two "Kyong-go" shall be counted as an addition of one (1) point for the opposing contestant. However, the final odd-numbered "Kyong-go" shall not be counted in grand total. A "Gam-jeom" shall be counted as an additional point for the opposing contestant.
- 4.3 When a contestant receives eight (8) "Kyong-go" or four (4) "Gam-jeom", or in the event of any combination of Kyong-go and Gam-jeom that add up to minus four points, the referee shall declare the contestant loser by penalties.

#### 5. Refereeing and protest

- 5.1 Refereeing will be conducted by WTF International Referees.
- 5.2 Refereeing officials will be composed of one (1) referee and four (4) judges. (In the case of using Electronic Body Protector, number of judges will be reduced to 2 or 3)
- 5.3 Refereeing officials with the same nationality as that of either contestant shall not be assigned to such a contest unless the number of refereeing officials is insufficient.
- In case there is an objection to a judgment regarding scoring, points and application of competition rules, the coach of a team can make a request to the center referee for an immediate review of the video replay. Each coach shall have one (1) chance to appeal per contest. If the appeal is successful and the contested point is corrected, the coach shall retain the appeal quota for the pertinent contest. The number of requests a coach can make all through the championships is limited to only one (1) in consideration of the total number of fights per contestant (maximum three matches per contestant). The decision of the Review Jury is final; no further appeals will be accepted during or after the contest, with exception of errors in determining the match results, mistakes in calculating the match score or misidentifying a contestant. In such instances, an official protest could be submitted according to the "Protest"

procedure after the match" in the WTF Competition Rules.

 Only one (1) appeal quota for video reply all through the championships:

#### 6. Weigh-in

- 6.1 Weigh-in of all participating athletes shall be completed on the previous day of the first day of competition.
- 6.2 At the time of weigh-in, the scale identical to the official one shall be placed near outside the place for weigh-in.
- 6.3 The scales identical to the official one shall be provided at the competitors' places of accommodation and/or training venues for pre weigh-in.

#### C. Athlete/team quota

#### 1. Quotas

- 32 places for men and women equally (8 competitors per weight category)
- 1.1 One National Federation can send the maximum two (2) male and (2) female athletes.
- 1.2 Only one athlete is allowed per weight category from one National Federation.
- 1.3 Host nation shall be given two (2) male and two (2) female quotas irrespective of the WTF World Ranking. Host nation shall have the right to select their athletes subject to approval of the WTF.

#### 2. Qualifications

- 2.1 Holder of taekwondo Dan certificate issued by Kukkiwon/WTF
- 2.2 Top rankers determined by the WTF based on the WTF World Ranking

#### 3. Nationality

Competitors must be of the same nationality as the participating National Federation. Verification of nationality will be done by inspection of passport. Other matters shall be complied with the Competition Rules <u>and</u> other related rules of the WTF.

#### D. WTF Qualification System

 WTF will select 8 top athletes (7 athletes in the weight divisions in which host nation participate) per weight category based on the WTF World Ranking.

#### 2. Invitation Process

- 2.1According to the WTF World Ranking in force as of February 1, 2010, the WTF will invite the top rankers to Sportaccord Combat Games.
- 2.2When making initial invitations, the WTF will select top 20 athletes (Eight athletes plus twelve substitute athletes) per weight division for the case of unavailability of any of top 8 athletes in initial invitation process.
- 2.3The weight categories of the athletes are based on the current World Ranking. National Federation cannot change the weight division.
- 2.4In the event that one country has more than 4 (maximum quota per National Federation) athletes qualified based on the WTF World Ranking, the WTF will ask the pertinent National Federation to select the four athletes among them. Once it has selected athletes, National Federation cannot change the athletes under any circumstances.

#### 3. Host Nation

- 3.1Host Nation will be automatically qualified in two male and two female divisions
- 3.2 Host Nation should confirm to the WTF of the weight categories it wishes to participate by no later than February 10, 2010.

#### 4. Universality

4.1 Universality might be taken into account in case WTF cannot secure 8 (7 in weight categories in which host nation participates) athletes per weight category among top 20 athletes per weight category mentioned in 2.2.

#### - MEETING MINUTES -

Meeting of the General Assembly Scandic Copenhagen / Grand Ball room October 13, 2009 / 2:00 PM

#### 1. Roll Call & Meeting called to Order

Dr. Chungwon Choue, WTF President and Chairman of the General Assembly declared the General Assembly opened and gave the floor to WTF Secretary General Jin Suk Yang.

Secretary General Yang informed the delegates of General Assembly that representatives from 125 Member National Associations (MNA) and 38 WTF Council Members were present and that a quorum for the General Assembly had been reached.

-NOTE-

Due to some late arrivals for the General assembly the final count was representatives from 130 MNAs and 38 WTF Council Members.

#### 2. President's Welcome Speech

Before the Chairman delivered his opening speech there was a suggestion from a MNA representative to change the order of point No. 4 and 5 on the Agenda.

Secretary General Yang answered that the Agenda for the General Assembly was presented to the WTF Council at its meeting on October 11, 2009 and that the WTF Council unanimously approved the Agenda for the General Assembly and thus have to be kept as it is.

The Chairman started his opening speech by announcing that taekwondo has been confirmed as one of the 26 "core" sports for the 2016 Olympic Games at the IOC session held in Copenhagen the week before. The Chairman went on to dedicate this triumph to all members of the taekwondo family who are dedicated to promoting taekwondo and its development as an Olympic Sport from the time it was a demonstration sport in the 1988 Seoul Olympics up until today. The news were met by applauds from the General Assembly.

The Chairman meant that taekwondo is evolving in the right direction. The international governance of taekwondo is more transparent, fair and professional than ever before. This is our accomplishment and our pride and we should congratulate each other for these accomplishments, the Chairman said.

The Chairman expressed his belief that with continued progress taekwondo would not only become a firmly established Olympic sport, but also a model international sport, setting the standards by which other international sports and sport organizations are measured.

Chairman Choue went on to welcome the MNA representatives and WTF Council members to the General Assembly on the occasion of the 2009 WTF World Taekwondo Championships

the biggest one ever held in taekwondo with athletes and officials from over 140 countries. The competitions would be covered by over 30 TV channels broadcasting the event to all the five continents. The video replay system and electronic body protectors would be used to ensure fairness in judging, he emphasized.

"The election today will determine the tone of the taekwondo movement for the next four years, and may very well determine the future of taekwondo", the Chairman said and added that he regardless of the outcome of the election hoped that everyone would keep on working together to drive the advancement of taekwondo forward.

The Chairman expressed his concern for the untrue accusations and fictional fabrications that had been circulated by both known and unknown senders during the election campaigning and the damaging effect such shortsighted acts would have on the taekwondo community and the image of taekwondo in the international sports community. The Chairman pointed out that it was our common responsibilities as leaders of the taekwondo family that reflects what we need to be and what taekwondo would be.

Chairman Choue hoped that we would soon restore our integrity and self-respect to be able to continue with our proud tasks which have begun to show fruitful results. The Chairman ended his speech by stating; "together as one, nothing will be impossible."

Before the Chairman moved on to the next point on the agenda he gave the floor to Mr. Musa Cicek, representative from Germany.

Mr. Cicek agreed with Secretary General Yang's previous statement that the Agenda for the General Assembly is to be decided by the WTF Council. However, he believed that this is something also to be decided by the General Assembly and therefore asked for point 4 and 5 to change place on the Agenda.

Mr. Abou M. Moubarack Lo, representative from Senegal, pointed out that in accordance with article 16.4 E of the WTF Rules & Regulations it is clear that the WTF Council approves of the Agenda for the General Assembly and that it in article 8 of the WTF Rules & Regulations, regarding the General Assembly, is no mention of approval of Agenda and that it was clear that no changes would be made on the agenda.

Secretary General Yang asked Mr. Jason Pfeffer for a clarification on the WTF Rules & Regulations regarding this matter.

Mr. Pfeffer replied that Mr. Lo had read the Rules & Regulations correctly.

The Chairman moved on to the next item on the agenda.

### 3. Approval of Minutes of the General Assembly in Izmir, Turkey on May 5, 2008

The Chairman motioned for the minutes of the General Assembly in Izmir, Turkey held on May 5, 2008 to be approved by the General Assembly.

The motion was seconded and carried by the General Assembly. The minutes of the General Assembly in Izmir, Turkey held on May 5, 2008 was approved by the General Assembly.

The Chairman informed that a total of estimated US\$ 8 million have been allocated to the WTF by the IOC after the 2008 Beijing Olympics. Accordingly, the Reform Fund guidelines for 2009 to 2012 will be decided by the newly organized WTF Council at its meeting to be held in Cairo, Egypt on November 29, 2009.

#### 4. Election of WTF Officials

Chairman Choue explained that as prescribed in article 11.9 of the WTF Rules & Regulations an Ad-hoc Election Committee were formed, chaired by WTF Council member, Mr. Ivan Dibos, and confirmed the final list of qualified candidates for the election.

The Chairman went on to in accordance with article 8 of the WTF Rules & Regulations appoint Mr. David Askinas, president of USA Taekwondo Inc, as Acting Chairman to preside over the election.

The Acting Chairman, Mr. Askinas, explained to the General Assembly that both candidates for the office of WTF President will leave the room during the pendency election. The Acting Chairman then proceeded to call upon Mr. Dibos to explain the election procedures to the General Assembly.

Before Mr. Dibos started his report he introduced Ms. Hanna Burns whom had been invited as an observer from the IOC.

Mr. Dibos started his report from the Election Committee.

The five members of the Election Committee were appointed on July 15, 2009 in accordance with article 11.9 of the WTF Rules & Regulations. The appointed members were as follows:

Mr. Ivan Dibos, Chairman

Mr. Jason Pfeffer, Member

Mr. Michel Madar, Member

Mr. Coleman Lee, Member

Mr. Tae Eun Lee, Member

The Election Committee meeting was held on August 5-6, 2009 at the WTF Headquarters in Seoul, Korea in full attendance of the members. The election committee decided the following: in case a candidate application lacks the proper documentation as prescribed in the

WTF Rules & Regulations or if the documents were received after the deadline of July 13, 2009, 24:00 hours, WTF Seoul Headquarters, Korean local time, the candidate's application would be declined. A CV was not a required document for candidature according to WTF Rules & Regulations.

For the office of WTF President four (4) candidates were approved by the Election Committee, two (2) candidates has since then withdrawn, accordingly two (2) candidates remain.

For the office of WTF Vice President five (5) candidates were approved by the Election Committee.

For the office of WTF Council member thirty one (31) candidates were approved by the Election Committee.

For the office of WTF Auditor three (3) candidates were approved by the Election Committee.

Mr. Dibos went on to explain the distribution of fourteen (14) WTF Council members in the five continental unions. In accordance with article 16.2 of the WTF Rules & Regulations a maximum of 14 WTF Council members will be elected, each continental union shall consist of at least one (1) and a maximum of five (5) council members. The five candidates who receive the most votes of their respective continental union shall be elected to the WTF Council, the remaining nine (9) positions shall be filled in accordance with the total number of votes received up to five WTF Council members per continent, this until fourteen (14) Council members have been elected. Mr. Dibos pointed out that the voting representatives could vote for up to 14 candidates for the office of WTF Council. In case more than 14 candidates were marked on the ballot, it would be invalid.

Mr. Dibos moved on and explained the function of the observers. Five (5) observers representing the continents of Africa, Asia, Europe, Oceania and Pan America will be appointed by the Acting Chairman on the recommendation of the delegates to supervise the process of the election including counting of ballots. The observers will be chosen among the non-voting representatives and those who do not run for election.

Mr. Dibos informed that ballots were to be distributed to MNA voting representatives one by one by calling the name of each country.

Mr. Dibos went on to inform of the speeches by candidates for election. Candidates for the office of WTF President are allowed to give a five (5) minute speech. Candidates for the office of WTF Vice President will have three (3) minutes. With this Mr. Dibos finished his presentation of the election procedures.

The Acting Chairman thanked Mr. Dibos and asked the General Assembly if they had any questions regarding the Election Procedure.

Mr. Adrian Tranter, representative from Great Britain asked for the total number of votes to be cast in the election for each office.

Mr. Dibos replied that this would be announced shortly.

Mr. Harish Kumar, representative from India, raised a question regarding the voting rights of the WTF Council members. Mr. Kumar meant that since there was now an Acting Chairman appointed and elections for WTF officials were to be held the voting rights of the WTF Council should seize to exist. Mr. Kumar went on to say that if the WTF Council were to vote this would be unethical and unfair. Mr. Kumar also meant that he believed the General Assembly to be for the MNAs without the WTF Council.

The Acting Chairman referred to Mr. Jason Pfeffer of the Election Committee to reply to the statement by Mr. Kumar.

Mr. Pfeffer clarified that according to article 8.6 of the Rules & Regulations the General Assembly shall be organized with the members of the WTF Council and representatives of the MNAs. In addition, in accordance with article 11.3 of the WTF Rules & Regulations, all members of the WTF Council begin their term of office at the end of the General Assembly which elected them. Their terms of office cease at the end of the General Assembly held during the year which they expire.

The Acting Chairman points out that this is a matter of changing the WTF Rules & Regulations and not an issue for this election. Mr. Kumar was allowed to make another statement.

Mr. Kumar stated that the voting right of the WTF Council members needs to be stated in the WTF Rules & Regulations. In the case that there is a tradition that is being followed that they have voting rights it is unlawful and unethical and can not be carried on. Mr. Kumar went on to state that the WTF Council consists of nominated members (by the WTF President) and thus should not be allowed to vote just like appointed members in a government are not allowed to vote.

The Acting Chairman intervened and explained that Mr. Kumar's comments were out of line since they have to do with rule change instead of the election. The Acting Chairman referred to Mr. Dibos for a reply to Mr. Kumar.

Mr. Dibos stated that rules governing a country have nothing to do with the rules of an International Sports organization such as the WTF.

Mr. Pfeffer pointed out that according to the WTF Rules & Regulations the General Assembly is defined as the WTF Council and the representatives of the MNAs. Mr. Pfeffer adds that the WTF Rules & Regulations state the qualifications to have voting right not that the WTF Council should not have voting rights.

The Acting Chairman gave to floor to Mr. Adrian Tranter, representative from Great Britain.

Mr. Tranter requested that officials running for re-election have to step down from their position before the election and added that there in article 16 of the WTF Rules & Regulations is no mention of the voting rights of WTF Council members.

Mr. Pfeffer replied that the precedence have to be taken into account that since the formation of WTF members of the WTF have been allowed to vote and also article 16.4 G of the Rules & Regulations which states that the WTF Council shall decide upon "other matters under its jurisdiction or responsibility, as prescribed in the WTF Rules & Regulations." Mr. Pfeffer went on to point out the responsibilities of the General Assembly listed in article 8 and emphasized that the General Assembly consists of the members of the WTF Council and representatives of the MNAs.

The Acting Chairman closed the debate on this subject since this matter referred more to rule changes than the election.

Mr. Gerrit Eissink inserted that this was an issue that had been raised before by the European Taekwondo Union and that they do not agree with the WTF Council members having voting rights since this is not clearly stated in the WTF Rules & Regulations.

Mr. Pfeffer replied by asking how Mr. Eissink who had been exercising his voting right as a member of the WTF Council for years suddenly found it to be against the rules now. Mr. Pfeffer once again pointed out that the General Assembly consists of the members of the WTF Council and representatives of the MNAs. Mr. Pfeffer recommended this change to be put forward at a later time under article 20 of the WTF Rules & Regulations.

The Acting Chairman moved forward since all voices on the matter had been heard and appointed the observers for the election. The observers are all non-voting representatives from MNAs to ensure that the ballot counting is done correctly and that there are no improprieties.

The observers were:

The Acting Chairman asked the General Assembly if there were any objections to the appointed observers. There were no objections.

Mr. Dibos pointed out that two of the observers had been appointed by the candidates for the office of WTF President, one by Dr. Nat Indrapana and one by Dr. Chungwon Choue.

The Acting Chairman thoroughly explained the voting procedure and strongly pointed out that no disturbance during the speeches of the candidates would be tolerated.

#### Election for the office of WTF President

There were two candidates for the office of WTF President, Dr. Chungwon Choue and Dr. Nat Indrapana.

#### Appendix 1

Dr. Chungwon Choue was re-elected for the office of WTF President with 104 votes to Dr. Indrapana's 45 votes.

Mr. David Askinas was relived of his duty as Acting Chairman of the General Assembly and Dr. Chungwon Choue elected WTF President took over as Chairman of the General Assembly.

#### Election for the office of WTF Vice President

There were five (5) candidates for three (3) offices of WTF Vice President.

The Chairman promised that for the next election of WTF Officials to be held during the General Assembly in 2013 that an electronic voting system will be used.

#### 5. Reports

The Chairman gave to floor to Secretary General Jin Suk Yang to present the Operational and Financial reports and the budget plan.

#### a. Secretary General's Reports

#### i. Operational and Financial Reports, Budget Plan

Secretary General Yang informed the General Assembly that all reports were printed in the Agenda for the General Assembly and asked if there were any questions from the General Assembly concerning the reports.

#### b. Treasurer and Auditors' Reports

Secretary General Yang gave the floor to WTF Auditor, Mr. Dalibor Krpan, to present his report.

Mr. Krpan informed the General Assembly that he had audited the financial documents and recommended the General Assembly to accept the financial reports.

The Chairman thanked Mr. Krpan and asked if there were any questions or comments to Mr. Kerpan's report.

Mr. Gerrit Eissink pointed out that WTF has two Auditors and that he would like to hear from the other auditor, Mr. Tae Eun Lee as well.

Secretary General Yang informed that Mr. Tae Eun Lee's report is enclosed in the Agenda.

Mr. Tae Eun Lee, WTF Auditor, informed the General Assembly that he had audited the financial documents and that he recommended the General Assembly to approve the financial report. Mr. Lee went on to point out that the actual spending figures of the WTF were lower than budgeted and commended the WTF for maintaining their expenses within budget.

#### Appendix 1

Mr. Gerry Joyce representing Ireland inquired why the loss on foreign currency transaction in the financial report was high.

Secretary General Yang replied that this was due to severe fluctuations between the US\$ and the Korean Won.

Mr. Joyce suggested that WTF could involve someone in foreign transactions who deals in currency to get better currency transaction fees.

Secretary General Yang replied that WTF has a liability towards its employees to pay salaries in Korean Won and thus WTF has no other choice than to convert US\$ into Korean Won to cover the expenses in Korea.

The Chairman motioned to have the Secretary General's reports approved by the General Assembly. The motion was seconded and carried. Secretary General's reports were approved by the General Assembly.

#### 6. Approval of new membership

The Chairman informed the General Assembly that Timor-Leste Taekwondo Federation recently applied for WTF membership and that all the administrative procedures had been completed for the approval of the General Assembly in Accordance with article 4 of the WTF Rules and Regulations.

The Chairman motioned that the General Assembly approve Timor-Leste Taekwondo Federation as a full member of the WTF. The motion was seconded and carried by the General Assembly.

The Chairman informed that WTF now has 189 members throughout the world and that several countries such as Oman, Maldives, Namibia and Botswana are currently going through formalities for affiliation and that his hope is to have over 190 Member National Associations within next year.

#### 7. Progress report from the Organizing Committee

- Taekwondo Competition of the 2012 London Olympic Games

The Chairman informed that they could choose if they wanted to hear the report from the LOGOC or if they wanted to receive the information per request from the WTF Secretariat. The General Assembly preferred to receive the information per request to the WTF Secretariat.

#### 8. Report on World Youth Camp

The Chairman reported that the World Taekwondo Youth Camp was held in Korea on August 6-10, 2009 with 33 participating countries. To celebrate this occasion the IOC President, Dr. Jacques Rogge, sent a congratulatory video message. The aim of the camp was to provide world youth with education on Olympic values and ideals as well as taekwondo spirit. The camp also aimed to inform the participants of the purpose and background of the creation of the Youth Olympic Games and the competition system of the Taekwondo Competition of the 1st Youth Olympic Games scheduled to be held in Singapore on August 15-19, 2010.

The Chairman went on to inform the General Assembly that the World Qualification Tournament for the 1<sup>st</sup> Youth Olympic Games will be held in Tijuana, Mexico on March 3-4, 2010 on the occasion of the 8<sup>th</sup> WTF World Junior Taekwondo Championships. 30 male and 30 female athletes will be selected to compete in 5 male and 5 female weight divisions at the 1<sup>st</sup> Youth Olympics.

#### 9. Other matters

The Chairman gave the floor to WTF Vice President Mr. Dai Soon Lee for a presentation on the progress of Taekwondo Park.

Mr. Dai Soon Lee reported that since the Groundbreaking Ceremony that took place on September 4, 2009 construction of the US\$ 185,000,000 Taekwondo Park is well under way and scheduled to open in 2013. The facilities to be included in Taekwondo Park are World Taekwondo Academy, Global Taekwondo Education and Research Center, Taekwondo Stadium, Taekwondo Training Center, Taekwondo Exhibition Hall, Taekwondo Hall of Fame, Taekwondo Experience Hall and many more. In May 2009 Samsung Consortium was selected for the construction of Taekwondo Park. The Groundbreaking Ceremony was attended by 1600 guests including several IOC members and Korean government representatives and the Korean Prime minister. The opening of the World Taekwondo Academy, one of the main facilities of Taekwondo Park, will coincide with the opening of Taekwondo Park in 2013 will be developed as an educational institute to produce global leaders promoting the human values unique to taekwondo. The World Taekwondo Academy will be a powerhouse to generate all the values which are indispensable for peace and prosperity in the world. To make this goal a reality we have been working hard on research and development of the curriculum in co-operation with the International Olympic Academy as well as scholars and taekwondo masters. An international symposium was held at UC Berkley in August 2009. The program will at the end of 2009 and then instruction manuals and textbooks will be produced. In 2013 the World Taekwondo Academy will open and formally start its mission.

After this introduction Mr. Dai Soon Lee presented a video presentation on the progress of the construction of Taekwondo Park.

Mr. Dai Soon Lee's presentation was applauded by the General Assembly.

The Chairman thanked Mr. Dai Soon Lee for his progress report on Taekwondo Park and moved on to the next item on the agenda.

#### 10. Next General Assembly

The Chairman announced that the next General Assembly is tentatively scheduled to be held in Tijuana, Mexico on March 2, 2009 on the occasion of the 8<sup>th</sup> WTF World Junior Taekwondo Championships and the WTF World Qualification Tournament for the Youth Olympic Games.

The Organizing Committee of the 8<sup>th</sup> WTF World Junior Taekwondo Championships showed a short video presentation on the 8<sup>th</sup> WTF World Junior Taekwondo Championships to be held in Tijuana, Mexico in 2010.

The Chairman thanked the OC of the WTF World Junior Taekwondo Championships for the presentation.

#### 11. Closing of the meeting

Chairman Choue started his closing speech by pointing out that this has been a gathering of one family united under the taekwondo spirit with common hopes and goals to create a more prosperous future for taekwondo as a global sport. The chairman informed that there might be a discussion within the IOC to select 25 core sports out of 26 in the Olympic Program for 2020 and he assured the General Assembly that he would do his utmost to keep taekwondo in the Olympic program. "However, I can not do it alone, we should work together to ensure progress in the sport of taekwondo to bring it to a new level of global competence." the Chairman stated.

Chairman Choue went on to inform that there would be a great change in the work of the WTF following the change of leadership and the council the administration will change as well. The Chairman urged everyone to keep in mind that regardless of what function or role you play in the WTF we should unite as one to survive in the ever more competitive sport world. Together as one, nothing will be impossible!

The Chairman asked for the full cooperation and support of the General Assembly to make taekwondo a truly global sport. And with this closing remark the Chairman declared the 2009 WTF General Assembly closed.
