#### **Article 1 Introduction**

- 1 The World Taekwondo (WT) was founded to promote the development and practice of Taekwondo worldwide in a sustainable way, from a grass roots level all the way through to an elite level, to provide all with the opportunity to play, watch and enjoy the sport regardless of age, gender, religion, ethnicity, or ability. (Preamble to the WT Statutes in effect as of December 15, 2023).
- 2 WT is a member of the International Olympic Committee (IOC) and the International Paralympic Committee (IPC) and has over 200 Member National Associations making it one of the most diverse international sport federations. (Preamble to the WT Statutes in effect as of December 15, 2023).
- 3 The objective of WT is to provide effective governance and administration of Taekwondo worldwide in accordance with the values and traditions of the martial art as well as the general and fundamental principles of good governance of the Olympic and Paralympic movements. (Article 2 of the WT Statutes in effect as of December 15, 2023).
- 4 Member National Associations ("MNAs") enjoy the right to participate in WT-promoted events, the Olympic Games, and the Paralympic Games, as well as hosting WT events, and accessing WT Development Programs. MNAs' requirements, among others, include completing the MNA Survey, participating in WT-promoted Championships, appointing delegates to the General Assembly, implementing the Global Membership System (GMS), and incorporating Para Taekwondo. (Article 8.4 and 8.5 of the WT Statutes in effect as of December 15, 2023).
- 5 In consideration of the above, and to enhance the harmonization of MNA activities worldwide, as well as to elevate the level of governance and participation among MNAs globally, WT has enacted these Member National Association Ranking Bylaws (hereinafter "MNA Ranking Bylaws").

# **Article 2 Ranking**

- 1 WT shall establish a ranking system for MNAs based on predefined criteria (refer to Article 3 Criteria).
- 2 The WT shall engage in an annual evaluation of all WT MNAs in accordance with the process set forth in these Bylaws.
- 3 MNAs shall be ranked into one of 10 categories, plus a separate category for inactive MNAs, based on their scores divided into deciles, which statistically separates the dataset into ten equal parts, as follows:
  - A1: Top 10% MNAs (scoring highest, encompassing the 9th-10th deciles).
  - A2: MNAs scoring between the 8th and 9th deciles.
  - B1: MNAs scoring between the 7th and 8th deciles.
  - B2: MNAs scoring between the 6th and 7th deciles.
  - C1: MNAs scoring between the 5th and 6th deciles.
  - C2: MNAs scoring between the 4th and 5th deciles.
  - D1: MNAs scoring between the 3rd and 4th deciles.
  - D2: MNAs scoring between the 2nd and 3rd deciles.
  - E1: MNAs scoring between the 1st and 2nd deciles.
  - E2: Bottom 10% MNAs (scoring lowest, encompassing 0-1st decile).
  - F: MNAs with 0 points or inactive status.

In each category, the highest decile is inclusive, meaning it includes the upper boundary, while the lowest decile is exclusive, meaning it excludes the lower boundary (which, according to this criterion, will be included in the next lower category).

- 4 WT shall announce the overall results of the MNA Ranking and provide a list of all categorized MNAs every year during the Ordinary General Assembly ("OGA").
- 5 The evaluation and ranking process shall be conducted by an Ad-Hoc Committee appointed by the WT President and overseen by the MRD Commission.
- 6 New MNAs shall be granted a one-year grace period regarding the ranking process.

#### **Article 3 Criteria for Point Allocation**

1 MNAs will be evaluated based on the following criteria, with a maximum of 100 points available for assessment, allocated as follows:

Governance: 50 points Participation: 25 points Performance: 10 points

Events: 10 points

Sustainability: 5 points

#### a. Governance

- i. Governance score, with a maximum of 50 points, is allocated through the biennial MNA Survey. The MNA Survey is an evidence-based assessment structured with a background section and 25 measurable indicators covering five principles: governance, transparency, integrity, democracy, and development. The 25 questions are scored on a 0-2 scale, with a maximum possible score of 50 points. Some of the questions require supporting evidence, such as file attachments or website links.
- ii. Following the collection of all responses, an independent moderation process is conducted to ensure fairness and consistency across all assessments. The Guidelines for MNA Survey shall serve as reference for detailed information about the scoring system.
- iii. The MNA Survey results are released every two years at the OGA. As the MNA Ranking is updated annually, the latest available results of the survey will determine point allocation in the governance category.

#### b. Participation

- i. Participation score, with a maximum of 25 points, comprises two components: participation in World Taekwondo promoted events (with a maximum of 17 points) and attendance at OGAs (with a maximum of 8 points).
- ii. For WT promoted events, the maximum score of 17 points is allocated based on athletes' participation in the following events, with a specific point limit per event:

World Taekwondo Championships: 3 points maximum

World Taekwondo Junior Championships: 3 points maximum

World Taekwondo Poomsae Championships: 3 points maximum

World Taekwondo Cadet Championships: 3 points maximum

World Taekwondo Para Taekwondo Championships: 3 points maximum

World Taekwondo World Cup Team Championships Final: 2 points maximum

iii. Participation points are determined as follows:

Mixed gender participation: 100% of the maximum points allocated for the

Single gender participation: 50% of the maximum points allocated for the event.

No participation: 0 points

In summary, if both genders participate, regardless of the number of athletes, the MNA earns full points (3 points for the listed events, except WT World Cup Team Championships Final which grants 2 points); if only one gender participates, they receive half the points (1.5 points for the listed events except WT World Cup Team Championships Final which grants 1 point).

- iv. Only the most recent edition of the listed events, held and concluded before the OGA where the MNA Ranking is updated, will be considered for earning points.
- v. For OGAs, the remaining 8 points are earned by attending the two previous editions before the OGA where the MNA Ranking is updated:

Ordinary General Assembly A (one year before): 4 points Ordinary General Assembly B (two years before): 4 points

For example, for the publication of the 2024 MNA Ranking, participation in the 2023 and 2022 OGAs will be assessed for obtaining ranking points, without counting the participation in the 2024 OGA.

#### c. Performance

i. Performance score, with a maximum of 10 points, is allocated based on the top-20 ranked MNAs in one of the Men's Team Standing or Women's Team Standing in each of the following events, with a specific point limit per event:

World Taekwondo Championships: 3 points maximum
World Taekwondo Junior Championships: 2 points maximum
World Taekwondo Poomsae Championships: 2 points maximum
World Taekwondo Cadet Championships: 1 point maximum
World Taekwondo Para Taekwondo Championships: 1 point maximum
World Taekwondo World Cup Team Championships Final: 1 point maximum

ii. Performance points are determined as follows:

Ranked in the top 10: 100% of the maximum points allocated for the event Ranked 11-20: 50% of the maximum points allocated for the event Not ranked in the top 20: 0 points

- iii. Performance points are not cumulative. The highest score among both men's and women's team standings in each event is considered for points allocation. For example, if an MNA is ranked top 10 in Men Team Standing and top 11-20 in Women Team Standing at WT Junior Championships, the MNA will receive 2 points for being ranked top 10 in Men Team Standing.
- iv. Only the most recent edition of the listed events, held and concluded before the OGA where the MNA Ranking is updated, will be considered for earning points.

#### d. Events

i. Events score, with a maximum of 10 points, is allocated by hosting World Taekwondo promoted events outlined in Article 11 of the WT Statutes. Points allocation is as follows:

10 points for hosting:

World Taekwondo Championships

#### 7.5 points for hosting:

World Taekwondo Junior Championships

World Taekwondo Poomsae Championships

World Para Taekwondo Championships

World Taekwondo Grand Prix Final

#### 5 points for hosting:

World Taekwondo World Cup Team Championships Final

World Taekwondo Grand Slam Champions Series

World Taekwondo Cadet Championships

World Taekwondo Grand Prix Series

World Taekwondo Grand Prix Challenge

#### 2.5 points for hosting:

World Taekwondo Deaf-Taekwondo Championships

World Taekwondo Beach Championships

World Taekwondo Urban Championships

World Taekwondo Poomsae Open Challenge

World Para Taekwondo Open Challenge

World Taekwondo World Cup Team Championships Series

World Taekwondo Club Championships

World Taekwondo Demonstration Team Championships

- ii. Points accumulate until reaching the 10-point maximum. For instance, hosting the WT Poomsae Open Challenge (2.5 points) and the WT Cadet Championships (5 points) grants 7.5 points. Hosting both a WT Grand Prix Final (7.5 points) and a WT Grand-Prix Series (5 points) earns the maximum of 10 points.
- iii. If Para Taekwondo Grand Prix events are hosted by a different MNA from the one hosting the equivalent able-bodied events, the hosting MNA of the Para Taekwondo Grand Prix events earns points equivalent to those of the able-bodied events (i.e., 7.5 points for the Final and 5 points for the Series).
- iv. Only the most recent edition of the listed events, held and concluded before the OGA where the MNA Ranking is updated, will be considered for earning points.

#### e. Sustainability

i. Sustainability score, with a maximum of 5 points, is allocated through the Sustainability Awards. Points are allocated as follows:

1st Place: 5 points
2nd Place: 3 points
3rd Place: 1.5 points
1 point for participation

ii. The Sustainability Awards are held annually and recognize the first, second, and third places in three specific categories aligned with the focus areas of the WT Sustainability Strategy:

Diversity, Equity & Inclusion and Community Environmental Sustainability Health & Well-being

iii. Only the most recent edition of the Sustainability Awards, held and concluded before the OGA where the MNA Ranking is updated, will be considered for earning points.

# Article 4 Benefits

- 1 MNAs may become eligible for specific benefits based on their overall scores and scores in each assessed area (governance, participation, performance, events, and sustainability) as determined by WT.
- 2 MNAs with the highest score in overall MNA Ranking and in each assessed area shall be recognized and awarded at the annual WT Gala Awards.
- 3 MNAs with low scores may be subject to certain limitations or consequences as determined by WT.

# Article 5 Validation of the Points

The awarded points of an MNA will be valid for one year. For the purpose of this rule, a year means the period between two successive OGA.

## Article 6 Effectuation

These Ranking Bylaws shall come into effect from May 12, 2024.

# Article 7 Update and Management of Ranking

The MNA Ranking will be updated in the month prior to the OGA, and the new MNA Ranking will be valid and published in the month of the OGA.

# Article 8 Interpretation

In case of divergence of interpretation, the decision of the MRD Commission shall prevail.

## Article 9 Amendment

These Ranking Bylaws shall be amended by approval of the WT Council.
