



**15th WT Taekwondo for All Committee Meeting (via conference call)

 - *Reported that first batch (60 shoes) in cooperation with Mooto, and the second batch (200 doboks, 25 head gears, 25 body protectors, 40 arm guards, 40 shin guards, 50 double mitts) in cooperation with TPC were sent to Zimbabwe Taekwondo Federation through Embassy of the Republic of Korea in Zimbabwe. Those shipping expenses were covered by IOC-IF Development Program. (Wooram)*
 - *According to the report from Embassy of the Republic of Korea in Zimbabwe, the equipment was distributed as a gift to the awardees of Online Taekwondo Poomsae Contest in Zimbabwe held in Oct. 3-9, 2021 jointly hosted by the Embassy of the Republic of Korea in Zimbabwe and Zimbabwe Taekwondo Federation and to Natsiraishe. (Wooram)*
 - *From the meeting with Natsiraishe, she has received mentioned equipment below from their Federation; however, it is not enough for her and her students. (Wooram)*
