Article 1

Objective

These regulations are to efficiently administer the International Classifiers of the WT in line with the World Para Taekwondo Athlete Classification Rules.

Article 2

Administration

Overall administration of all Classifiers shall be made by the World Para Taekwondo Department with the assistance of the Head of Classification as prescribed by the IPC Athlete Classification Code and World Para Taekwondo Athlete Classification Rules.

Article 3

Qualification

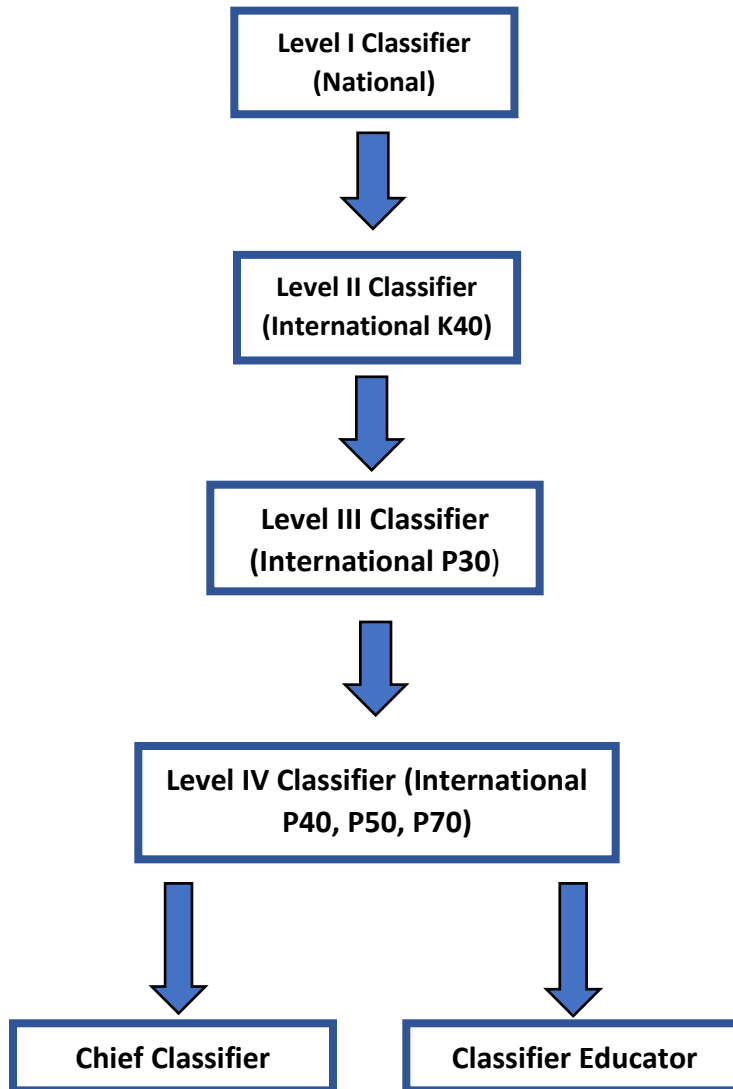
- 3.1 WT will grant qualification as Level I Classifier (National) to those who have attended the online or physical Level I Classifier (National) Course and successfully completed prescribed examination.
- 3.2 WT will grant qualification as a Level II ClassifierLevel II Classifier (International K40 Sport Class) to those who have completed Level I and attended and successfully completed the Level 2 practical exam as well as trainee evaluation at two International Para Taekwondo Championships with a minimum of 20 K40 athletes
- 3.3 WT will grant qualification as a Level III Classifier (International P30 Sport Class) to those who have successfully passed Level I, Level II as well as Level III practical exam and as trainee evaluation at two International Para Taekwondo Championships with a minimum of 20 P30 athletes.
- 3.4 WT will grant qualification as Level IV International Classifier for (P40 ,P50, P70 Sport Classes) for those who have successfully Completed Level I, Level II as well as practical exam of Level IV Classifier (International P40, P50, P70) Course and International Classifier trainee evaluation at two International Para Taekwondo Championships with a minimum of 20 P40,P50,P70 athletes.

Article 4

WT Classifier Pathway

All certification courses will be run by WT under the auspices of the Para Taekwondo Head of Classification (HoC).

Classifier Pathway



Article 5

Level I Classifier (National)

Level I Classifier (National) Course is an online or physical course open to those interested in finding out more about WT Para Taekwondo Classification. Basic classification knowledge to include sport class profiles and classification process. Pre-reading and assignments will allow national classifiers to use translation services if needed.

- 5.1 Participant profile includes but not limited to athletes, coaches, competition organizers, referees, medical professionals who have:
 - 5.1.1 Taekwondo specific knowledge and/or certified medical professional in a field relevant to the Impairment category which WT at its sole discretion deems acceptable as detailed in the Athlete Classification Rules, e.g., physicians and physiotherapists for Athletes with Physical Impairment
 - 5.1.2 An extensive coaching or other relevant background in the sport of Taekwondo. e.g., sport science and or sport-specific expertise, which WT at its sole discretion deems to be acceptable.

Candidates must be requested to submit a current CV.

5.2 Learning outcomes

Upon completion of the online or physical course participants will have a good understanding of:

- The IPC and WPT rules, regulations, and code of conduct.
- General Para Taekwondo Sport Classes and Sport Class Status
- Roles and responsibilities of the athlete, coach, and classifiers in the classification process
- Para Taekwondo medical and technical terminologies
- How to interpret the medical diagnostic form (MDF)
- Use of the World Taekwondo Classification System (WTCS)
- Classifier tools and how to set up the classifiers room
- General medical and technical assessments of sport classes
- Observation assessment procedure and allocation of sport classes
- Filling in the classifiers notes in a championship

5.3 Program recognition

Upon completion of the course all participants will be given a certificate of participation. Participants who passed the written exam with at least 70% will be awarded a Level I Classifier (National) Certificate and will be eligible to proceed to Level II Classifier (International K40) Certification Course.

5.3.1 Registration fee for the National Classifier Level I Certification Course will be presented in the outline for each course.

5.4 Failure to pass examination

Candidates who do not successfully pass the theory examination will be allowed to only attend the next available course free of charge.

Article 6

Level II Classifier (International K40)

This course is practical in nature with the intent to have Level II Classifier (International K40) courses in person. Pre-reading and assignments will allow national classifiers to use translation services if needed

6.1 Pre-requisite

- Completion of Level I Classifier (National).
- Have taekwondo specific knowledge and/or medical expertise and experience working with persons with either physical or neuro muscular impairments.
- Knowledge of the WT Para Taekwondo Competition Rules and WPT Athlete Classification Rules.
- Willing to commit to classification internationally at least once or twice per year.
- Signed code of conduct and confidentiality.
- At the discretion of the HoC a person deemed to have the qualification, knowledge and expertise can be fast tracked to Level II course.
- Must understand that they may not be active or have any roles and responsibilities apart from being an International Classifier e.g., as a coach, referee, MNA administrator, athlete or medical support for their national team, and be willing to commit to attending competitions as a WT International Classifier.
- Proficient in English, oral and written

6.2 Learning outcomes

Upon completion, the participants will have the knowledge and tools necessary to competently classify on an international basis with good understanding of.

- Understand the IPC Classification Code and it's relation to the World Para Taekwondo Classification Rules.
- Understand and complete K40 athlete evaluation using World Para Taekwondo assessment methods.
- Able to correctly place athletes in the correct K40 Sport Class
- Sport Class Status
- Implement the use and interpretation of Medical Diagnostic Form (MDF)
- Be aware of protest procedures and risk management and the impact of misrepresentation on classification.
- Differentiate between misrepresentation and non-cooperation of an athlete.
- Complete athlete observation in competition
- Allocate Sport Class and Sport Class Status
- Complete classifier notes including observation assessment form

6.3 Program recognition

- 6.3.1 Upon successful completion of practical Level II course, you will be issued with a certificate acknowledging you have passed the examination.
- 6.3.2 To be fully certified as Level II Classifier (International K40) you will have to successfully pass two international classification evaluations as a trainee with a score of 70% by senior international classifiers & approval of the head of classification.
- 6.3.3 Evaluation will occur at a minimum of two (2) practicums and a minimum of twenty (20) athletes.
- 6.3.4 Depending on your qualification and performance as a trainee you will be certified as an International Medical Classifier or International Technical Classifier.
- 6.3.5 If you fail any of the evaluations as a Level II classifier trainee, you will be given a third chance to be re-evaluated. If you fail your third evaluation you must retake the Level II Course.

6.4 Program Recognition

- 6.4.1 Upon successful completion of the course and two classifier trainee evaluations at International Para Taekwondo Championships participants will receive a certificate as Level II Classifier (International K40 Medical or Technical).
- 6.4.2 They will be eligible to attend Level III Classifier (International P30) course and must do so within one year.
- 6.4.3 If the Level II Classifier (International K40) has not taken and successfully passed the Level III Classifier (international P30) Course within a year, they will lose their certification as a Level II Classifier (International K40) and must retake the Level II course.
- 6.5 Registration fee for the National Classifier Level II Certification Course will be presented in the outline for each course.

Article 7

Level III Classifier (International P30)

This course is practical in nature with the intent to have Level III Classifier (International P30) Pre-reading and assignments will allow classifiers to use translation services if needed

7.1 Pre-requisite

- Completion of Level I Classifier (National) Course, Level II Classifier (International & Trainee K40) Course
- Have Taekwondo specific knowledge and/or medical expertise and experience working with persons with either physical or neuro muscular impairments
- Knowledge of the WT Para Taekwondo Competition Rules and WT Athlete Classification Rules
- Willing to commit to classification Internationally at least once or twice per year
- Signed code of conduct and confidentiality
- Must understand that they may not be active or having any roles and responsibilities apart from being an international classifier e.g., as a coach, referee, MNA administrator, athlete or medical support for their national team, and be willing to commit to attending competitions as a WT International Classifier
- Proficient in English, oral and written

7.2 Learning outcomes

Upon completion, the participants will have the knowledge and tools necessary to competently classify on an international level:

- Understand the IPC Classification Code and its relation to the World Para Taekwondo Classification Rules.
- Understand and complete P30 Athlete evaluation using WT Para Taekwondo assessment methods
- Able to correctly place athletes in the correct P30 Sport Class
- Be aware of protest procedures and the impact of misrepresentation on classification
- Differentiate between misrepresentation and non-cooperation of an Athlete
- Complete Athlete Observations in Competition.
- Allocate sport class and sport class status
- Complete classifiers notes including observation assessment form

7.3 Level III Classifier Trainee

- 7.3.1 Upon successful completion of practical Level III course, you will be issued with certificate acknowledging you have passed the examination
- 7.3.2 To be fully certified as Level III Classifier (International P30 0) you will have to successfully pass two international classification evaluations as a trainee with a score of 70% by Senior International Classifier & approval of Head of Classification. Evaluation will occur at a minimum of two (2) practicums. and a minimum of twenty (20) P30 athletes.
- 7.3.3 Depending on your qualification and performance as a trainee you will be certified as an International Medical Classifier or International Technical Classifier.
- 7.3.4 If you fail any of the evaluation as a Level III classifier trainee, you will be given a third chance to be re-evaluated. If you fail your third evaluation you must retake Level III Course.

7.4 Program recognition

- 7.4.1 Upon successful completion of the course and two classifier trainee evaluations at International Para Taekwondo Championship, participants will receive a Certificate as Level III (International P30 0 Medical or Technical) Classifier
 - 7.4.2 They will be eligible to attend Level IV International Classifier Course (P40, P50, P70) and must do so within two (2) years.
 - 7.4.3 3 If the Level III Classifier (International P30) has not taken and successfully passed the Level IV Classifier Course (international P40, P50, P70) within two years they will lose their role as a Level III Classifier (International P30) and retake the Level III course
- 7.5 Registration fee for the Level III Classifier (International P30) course will be presented in the outline for each course

Article 8

Level IV Classifier (International P40, P50, P70)

8.1 Participation profile

- 8.1.1 Medical Classifiers who have been certificated as Level III International Classifier P30 or with the latest valid WT International Classifier recertification certificate.
- 8.1.2 Technical Classifiers who have been certificated as Level III International Classifier P30 or with the latest valid WT International Classifier recertification certificate.
- 8.1.3 The WT Head of Classification also has the right to recommend candidates to become classifiers.

8.2 National Quota

WT may limit the number of applicants for International Classifier Seminar or course per country to seek for balanced development of para taekwondo taking into account a number of factors including regions and countries and balance between medical and technical classifiers, male/ female and number of athletes per region or country.

8.3 Course pre-requisites

- Level III Classifier (International P30) Certification or any International Classifier with the latest recertification from WT.
- Must understand that they may not be active or having any roles and responsibilities apart from being an international classifier e.g. as a coach, referee, MNA administrator, athlete or medical support for their national team, and be willing to commit to attending competitions as a WT International Classifier
- Have Taekwondo specific knowledge and/or medical expertise and experience working with persons with either physical or neuro muscular
- Knowledge of the competition rules
- Willing to commit to classification Internationally at least once or twice per year
- Signed code of conduct and confidentiality
- WT License number
- Proficient in English, oral and written

8.4 Learning outcomes

The Level IV Classifier (International P40, P50, P70) Course may consist of reading, face to face practical and theory review. On completion of the course participants will be required to take a written examination and achieve a minimum of 70% in theory & practical based on either medical testing or technical testing. Participants will be able to do the following:

- Understand the IPC Classification Code and its relation to the World Para Taekwondo Classification Rules.

- Successfully administer Athlete Evaluation at (P40, P50, P70) competitions.
- Understand and implement current policies and procedures for athlete evaluation and protests
- Differentiate between misrepresentation and non-cooperation of an Athlete
- Complete Athlete Observations in Competition.
- Allocate sport class and sport class status
- Complete classifiers notes including observation assessment form

8.5 Program recognition

- Upon successful completion of the course and two classifier trainee evaluations at International Para Taekwondo Championship, participants will receive a Certificate as Level IV participants will receive a Certificate as (International P40, P50, P70 Medical or Technical) Classifier
- With the discretion of the HOC, Educators/research who is an international classifier and have worked on education material and conducted Level IV course can be fast tracked to Level IV Classifier (P40, P50, P70) Certification

Article 9

International Classifier Re-Certification

Purpose of International Classifier Certification Maintenance. International Classifier Re-Certification seminars may consist of a practical course and/or online seminar.

The WT conducts the International Classifier Re-Certification Seminar for:

- education on amended WT Athlete Classification Rules and updated classification procedures, tests, etc., and
- improving the knowledge of an International Classifier as a member of a classification panel.

9.1 Term of Certification

9.1.1 Certification of International Classifiers is for four (4) years. In that time the Classifiers are expected to classify as part of an international panel a minimum of once a year. When certification expires Classifiers must attend and successfully complete a re-certification course at a time and place designated by Head of Classification. Classifiers who do not participate as an international classifier in a season and do not take part in seminar(s) provided by WT may not be appointed to a Classification Panel.

9.1.2 If certification is not renewed the classifier will not be assigned to any further competitions. A review of rules and procedures will be done prior to each competition by the Chief Classifier.

9.1.3 A database of accredited classifiers is held by WT including competitions attended and seminars attended.

9.2 Suspended International Classifiers

- Classifiers under suspension or disciplinary measures in accordance with Article 15 of these regulations are not allowed to attend International Classifier Re-Certification Seminars.

9.3 Issuance of achievement certificate

- An achievement certificate is given to the one who has passed an International Classifier Re-certification Seminar.

9.4 Attendance fee

- Attendance fee for the International Classifier Re-Certification Seminar will be presented in the outline for the seminar.

9.5 International Classifier Re-Certification Seminar

The International Classifier Seminars shall be conducted by WT only, and the outline of the seminar may include but is not limited to the following:

IPC Athlete Classification Code and Internal Standards:

- Code of Conduct and Confidentiality
- Roles and responsibilities of classifiers

Athlete Evaluation

- Eligible impairments and health conditions
- Minimum Impairment Criteria and how it is established
- Medical Testing protocols and training
- Sport Profiles Kyorugi and Poomsae
- Administrative Procedures
- Technical Assessment
- Explanation of the tests and brief demonstration
- Terminology
- Practical application
- Medical assessments
- How to observe and evaluate trainees during classification under the supervision of current international classifier panels
- Working knowledge of the WT Classification System (WTCS)

Article 10

General Information

10.1 Attendance Fee

Prescribed fee of attendance shall be paid.

10.1.1 WT may waive the attendance fee for candidates that have been identified to be an asset to the further development of Para Taekwondo and Classification

10.1.2 Airfare and accommodation for courses, practicums and seminars, all expenses including attendance fee, airfare and accommodation may be borne by the participant or the MNA.

10.2 Activation

10.2.1 Those who have successfully passed the examination at Level I shall receive a certification as a Level I Classifier (National) and proceed to Level II.

10.2.2 Those who have successfully passed the examination at level II and two international training evaluation shall receive a certification as a Classifier Level II (International K40) and can proceed to level III classifier (International P30).

10.2.3 Those who have successfully passed Level III examination and two international training evaluation shall receive a certification as a Classifier Level III (International P30 0) and can proceed to level IV.

10.2.4 Those who have successfully passed Level IV examination and two international training evaluation shall receive a certification as a Classifier Level IV (International P40, P50, P70).

10.3 Classifier uniforms

10.3.1 Formal uniform

- Jacket: Black
- Dress Shirt: Burgundy
- Pants: Black
- Scarf: WT

10.3.2 Informal uniform

- WT Classifier polos

10.3.3 Specification of uniform, including shape and fabric material, shall be decided by WT.

Article 11

Promotion

11.1 Chief Classifier

- One year after promotion to Level III Classifier (International P30) or Level IV Classifier (International P40, P50, P70) a Classifier may apply to become a Chief Classifier.
- A Chief Classifier will have successfully passed the theory examination and interview by the Head of Classification and or Panel of Senior Classifiers and has participated in classification panels at WT recognized or promoted Para Taekwondo events on four (4) or more occasions over a period of at least two (2) years.
- Those who have successfully passed chief classifier written examination and interview shall receive a certification as a Chief Classifier valid for 4 years.
- Only a classifier with a level IV certificate and a Chief Classifier Certification can be appointed as a Chief Classifier in a P40, P50 or P70 championship
- To be recertified as a chief classifier, you should have attended a WT recognized or promoted Para Taekwondo event at least once per year
- A Chief Classifier must show evidence of leadership and strong knowledge of the WT Athlete Classification Rules. A Chief Classifier may be put in charge of all classification at a WT recognized Para Taekwondo event where he/she will oversee two (2) or more panels.

11.2 Classifier Educator

- A medical or technical international classifier who have experience from two or more major events and have been identified as having educational qualities can be appointed by the HoC as a classifier educator for WT classifier courses.
- The head of classification can appoint an external expert with the knowledge and experience in a specific field relevant to Para Taekwondo Classification

Article 12

Selection and assignment of International Classifiers

12.1 Events and assignment of International Classifiers

The WT-HoC will assign International Classifiers for the Para Taekwondo competitions of the following events:

- WT World Para Taekwondo Championships
- IOSDs' multisport events
- IPC Continental Games
- Continental Union Championships
- Any other WT recognized Para Taekwondo event

The WT Head of Classification will make the assignments upon the request of the WT Administration. Every effort will be made to appoint classifiers from within the region of the event although it may be necessary to appoint classifiers from other regions due to availability.

12.2 Chief Classifier appointment

The Chief Classifier (CC) is an International Classifier appointed by the WT to direct, administer, coordinate and implement Classification matters for a specific competition. The Chief Classifier is responsible for the following, but not limited to:

- Supervise Classifiers to ensure that the Classification Rules are properly applied during Classification; to include but not limited to managing the on-site scheduling of athlete evaluation
- Manage Protests in consultation with WT;
- Liaise with the WT/LOC to ensure that (Classification Facilities, paperwork, etc.) are arranged in order that Classifiers may carry out their duties at the Competition.
- Ensure that the athletes meet eligibility criteria through monitoring the MDFs submitted prior to competition.
- Create notifications and publish classification results for both MNA and competition management
- Complete a final report to the WT and Tournament TD at the end of the competition noting difficult cases or issues that need to be addressed.
- The Chief Classifier may delegate specific responsibilities and/or transfer specific tasks to other appropriately qualified Classifiers.
- The appointed Chief Classifier may not participate as a member of a panel or have any duties not assigned by WT at a competition.

12.3 Appointment of International Classifiers

- To be appointed to a Classification Panel the classifier must hold a valid certification as a level II (International K40), Level III (International P30), Level IV (International P40, P50, P70) Classifier and 2021 International Classifier recertification
- Trainees must be appointed by HoC to attend their practicums at WT International Competitions. Or inform the Hoc of their availability.
- Trainees may start their first practicum at the same competition that hosts the Level II, Level II or Level IV course they attend, based on availability of trainee slots and selection by Head of Classification.

12.4 The ratio for the appointment of panels (one (1) medical and one (1) technical classifier per panel) will be as follows:

- One (1) panel per twenty-four (24) athletes
- Two (2) panels per forty-eight (48) athletes

For competitions with more than fifty (50) athletes to classify the number of panels will be on the decision of the HoC.

Scheduling shall ensure that classifiers will not be assigned more than nine (9) hours (including breaks) of athlete assessment a day during Athlete Evaluation. Classifiers will be given regular breaks during the day and will be given one (1) hour meal breaks.

12.5 Support / Payments

- Organizing Committee will provide selected International Classifiers with airfare, visa fees, reasonable local transport and other pre-negotiated expenses plus per diem in accordance with the WT Financial Rules per working day.
- Arrival time of classifiers at competition should be a day before classification in the morning or early afternoon.
- Travel insurance should be provided for International Classifiers or reimbursed by the OC
- WT will provide the service of coordinating the details and billing the Organizing Committee at the end of the competition. The Para Taekwondo tournament or championships organizer will provide accommodation of room and board and transfers to airport or other transportation locations at the organizers expense.
- If OC did not reimburse classifiers after 3 weeks WT will provide reimbursements to classifiers and request the OC to pay back WT.

12.6 Appointment and Visas

WT will ensure International Classifiers who have been selected as a member of a panel at a WT competition will be provided with a letter of appointment and, if needed, facilitate a letter of invitation or information needed for visa applications.

Article 13

Selection and appointment of Level II, Level III, Level IV Classifier Trainee

13.1 Trainees must be appointed by HoC to attend their practicums at WT International Competitions

13.2 Trainees may start their first practicum at the same competition that hosts the Level II, Level II or Level IV course they attend, based on availability of trainee slots and selection by Head of Classification.

Article 14

Duty

- 14.1 The International Classifier shall abide by all the rules with pride and dignity as an International Classifier of the WT.
- 14.2 The International Classifier shall be familiar with the WT Athlete Classification Rules and the guiding principles concerned.
- 14.3 The International Classifier must abide by the Classifier Code of Conduct
- 14.4 The International Classifier shall officiate at any Para-Taekwondo events with impartiality in the decision made by international classification panels. The international classifier must sign and abide by the Classifier Confidentiality Code. The International Classifier may not hold any function within a National Para Taekwondo Team
- 14.5 The International Classifier shall wear the uniform designated by the WT
- 14.6 The International Classifier shall conduct themselves in such a way that they do not discredit the WT
- 14.7 International Classifier shall inform both of the pertinent National Member Association and the WT of any changes in his/her postal address, telephone/fax numbers, e-mail address, etc. by registering online at web-based Taekwondo Membership System and he/she shall be responsible for any disadvantages due to lost contact.
- 14.8 International Classifiers who have been selected to officiate at any official event of the WT shall participate in the event, unless there is a justifiable reason for their absence, and attend the Classifiers' Meeting and Training before the start of the competition.

Article 15

Disciplinary Measures

- 15.1 If an International Classifier has committed any infractions of the Classifiers Code of Conduct, the WT may take disciplinary measures such as warning, rebuke, suspension or revocation of qualification in accordance with the regulations on sanctions of the WT.
- 15.1.1 In case of committing any behaviours bringing disrepute of the WT in relation to international classification, the pertinent International Classifier shall be disciplined by loss of certification or other form of disciplinary measures. Classifiers may not receive gifts of money or other valuables in relation to with a classification decision or protest. If they are found to have received inappropriate gifts they will be open to sanctions and possible loss of certification.
 - 15.1.2 In case of violation of the duties of International Classifiers prescribed in Article 14. "Duty."
- 15.2 When the limit of disciplinary measures is decided, the WT shall notify the International Classifier and the National Member Association of the result.
- 15.3 Other disciplinary measures against International Classifier's misconducts shall be taken according to the regulations on sanctions of the WT.

Article 16

Implementation

- 16.1 These regulations shall be effective as of April 20, 2022
- 16.2 All the existing International Classifiers accredited before the effective date of these regulations shall be recognized by these regulations.

Appendix 1

WT Para Taekwondo Classifier Code of Conduct

The role of WT Classifiers is to act as impartial evaluators in determining an athlete's Sport Class and Sports Class Status. The integrity of classification in WT rests on the professional conduct and behavior of each individual Classifier.

Classifiers should value and respect the athletes and athlete support personnel and:

- Treat athletes and athlete support personnel with understanding, patience, and dignity;
- Be courteous, objective, honest and impartial in performing their classification duties for all athletes, regardless of team affiliation or national origin;
- Accept responsibility for all actions and decisions taken and be open to discussion and interaction with athletes and athlete support personnel in accordance with the International Standard for Athlete Evaluation, the International Standard for Protest and Appeals, and the International Federation and/or Competition rules;
- Perform classification duties and related responsibilities while not being under the influence of alcohol or illegal substances;
- Maintain confidentiality of athlete information where ever possible, according to the International Standard for Athlete Evaluation and the International Standard for Protest and Appeals.

Classifiers should respect the Classification Rules and:

- Accurately and honestly represent their qualifications and abilities when applying for training and certification and when accepting classification appointments to competitions;
- Understand the theory and practical aspects of the Classification Rules and make them widely known and understood by athletes and athlete support personnel;
- Continuously seek self-improvement through study of the sport, Classification Rules, mentoring lesser-experienced Classifiers and developing trainee Classifiers;
- Perform duties without yielding to any economic, political, sporting or human pressure;
- Recognize that anything that may lead to a conflict of interest, either real or apparent, must be avoided.
- Disclose any relationship with a team, athlete or athlete support personnel that would otherwise constitute a conflict of interest.

Classifiers should respect their colleagues and:

- Treat all discussions with colleagues as confidential;
- Explain and justify decisions without showing anger or resentment;
- Treat other Classifiers with professional dignity and courtesy, recognizing that it is inappropriate and unacceptable to criticize other Classifiers, Games Officials or Technical Advisers in public;

- Publicly and privately respect the decisions and decision making process of fellow Classifiers, Games Officials and Technical Advisors whether you agree or not;
- Share theoretical, technical and practical knowledge and skills with less experienced Classifiers and assist with the training and development of Classifiers in their respective sports in accordance with the International Standards for Classifier Training and Certification.

GUIDING PRINCIPLES

Classifiers perform a professional role and voluntarily observe a high-level of professional and ethical conduct and behavior, not because of fear of penalty but out of personal character and dignity.

CONSEQUENCES AND SANCTIONS

Classifiers must acknowledge and accept that disciplinary action against them may include a variety of sanctions from verbal or written reprimand to revoking their certification as a Classifier for the WT as found in Section 5 of the Regulations on the Administration of International Para-Taekwondo Classifiers.

CONSEQUENCES OF NON-COMPLIANCE WITH CLASSIFIER CODE OF CONDUCT

In cases where a Classifier fails to meet the code of conduct and behaves in a way that is inappropriate or unprofessional, he/she will be given a verbal warning. If the behavior persists, the Chief Classifier will issue a written warning that will consider sending the Classifier home.

All incidents will be reported to the Head of Classification.

Appendix 2

Confidentiality Agreement for Classifiers in Training

As an International Classification trainee, I understand and accept the following.

I understand failure to conduct myself in a professional manner and any breaches of confidentiality will affect my ability to attain full WT international classification accreditation.

I have been informed of the evaluation process and understand the practical aspect of the accreditation process. I understand that the practical evaluation will be discussed with me and that my evaluation will be used to determine my status or need for further education.
