# 1. Overview and Schedule

### 1.1. Background

World Taekwondo Member Relations & Development (WT MRD) annually executes the Development Program to ensure the equitable and continuous development of Member National Associations (MNAs) under the umbrella of World Taekwondo (WT). Meanwhile, the IOC Development Fund (DF) team asked WT to start a DF program targeting the Oceania small island. Since it is difficult to visit the island countries of Oceania every day, WT decided to visit Honiara in the Solomon Islands, where the Pacific Games will be held. Through this visit, WT MRD aims to encourage the development of the National Sport System in the small islands of Oceania through Taekwondo, enhancing international event participation opportunities.

Upon the request of some National Olympic Committees (NOCs) in the South Pacific, planning development projects for the 2032 Brisbane Olympic Games in association with the Olympic Solidarity Program of the International Olympic Committee (IOC), the involvement of WT was sought. Thus, WT intends to revitalize Taekwondo as a key sport for these NOCs, fostering youth athletes' participation in the Brisbane 2032 Olympic Games.

### 1.2. Objectives

Attend the 2023 Pacific Games in the host city to meet directly with MNA representatives from small island MNAs in Oceania for a status assessment and identification of practical needs.

Collaborate with the IOC on-site to explore efficient support methods

Olympic2024 Qualification Tournament

- Coach and referee training needed before the Oly 2024 Qualification Tournament in April 2024.
- Participants' airfare is a significant concern for the OTU.
- IOC may support athletes' airfare and visa fees for the event.
- The organising committee (OC) will prepare accommodation and local transportation.
- IOC support requires a mandatory budget and plan submission for the reimbursement process through the IF.

Joint Training Camp in the Solomon Islands

- WT plans to send a coach and a few athletes to the Solomon Islands in January 2024 for joint training with the Solomon Islands and Kiribati athletes.
- Detailed discussions will follow for equipment, training facilities, and accommodation support for the joint training camp.

Annual National Championships

NZL MNA-NOC Relationship

- NZL MNA is actively working to improve its relationship with its NOC.

- NZL athletes are not participate to Pacific game due to OUT&NOC were not recognized as NF.
- NZL president will visit to WT on Jan to see SG.

MNA Efforts for small islands in Oceania

- NZL MNA is conducting an instruction training course and Poom/Dan grading test through the Kukkiwon Oceania Branch set in New Zealand to support the self-sufficiency of small MNAs in the South Pacific.

Challenges in the South Pacific

- The South Pacific region faces challenges in executing long-term coaching assignments due to a lack of applicants and the high cost of airfare between island nations.

Seeking solutions

- Discussions with Kukkiwon, Taekwondo Promotion Foundation (TPF), and KOICA are necessary to explore solutions and address the identified challenges.

#### 2.5.3. Details

Overview of Northern Mariana Islands (NMI)

- NMI has a total of 19 sports federations, with the football association being a FIFA member. However, Taekwondo is not yet an official sport recognized by the NMI National Olympic Committee (NOC). Despite this, due to its status as a U.S. territory, NMI cannot participate in the Olympics.

Taekwondo Clubs and Challenges

- There are Taekwondo clubs in the Northern Mariana Islands, but they are all individual businesses, making it challenging to assess the current situation.

Challenges Due to Typhoons

- The region faces difficulties in sports promotion due to the large but frequent typhoons, causing disruptions in domestic sports activities and infrastructure.

#### Potential Benefits of WT Membership

- Becoming a World Taekwondo (WT) member would open up opportunities for coach and referee training through the Oceania Taekwondo Union (OTU) and provide assistance in establishing association statutes and policies.



Accommodation Arrangements

- Athletes from the Solomon Islands and Kiribati are flexible in staying at accommodations near the basketball court of the 2023 Pacific Games. However, specially invited coaches and athletes should be prepared to reside in designated apartments (Capital Park).



Meal Preparations

- It is suggested to provide meals in the form of packed lunches, aiming to reduce athletes' movement, enhance safety, and focus on efficiency.

Utilization of Training Facility

- The basketball court of the current Pacific Games venue is proposed as a suitable training facility.

Support for Solomon Islands (SOL) MNA

- There are ongoing plans to support the Solomon Islands MNA in integrating Taekwondo into the 2024 school curriculum. The aim is to incorporate Taekwondo into the educational program as part of physical education.

Joint Training Schedule

### 2.9.3. Details

IOC Support for DNSS Project

- The IOC is currently in discussions to support the DNSS project through the TGA National Olympic Committee (NOC).

Training Facilities and Equipment in Tonga

- Tonga lacks a dedicated taekwondo training facility. There is a need for a space, mats, training equipment such as kick pads and Protector Scoring Systems (PSS), and a program with coaches for ongoing training.

Introduction of Taekwondo in School Curriculum

- Tonga MNA is working collaboratively with the Ministry of Education and the Ministry of Sports to introduce taekwondo into the school curriculum in 2024.

Current Challenges and Initial Operations

- Despite various limitations, Tonga MNA plans to initiate operations using locally available taekwondo enthusiasts and support from South Korea, including uniforms and belts.

Participation in World Taekwondo Championships

- Due to limited information, knowledge, and budget constraints, participating in the World Taekwondo Championships is currently challenging for Tonga team.

Recruitment of Coaches and Training Opportunities:

- The most pressing need is for coaches, but recruitment in the South Pacific is challenging. As an alternative, WT is exploring the option of inviting TGA athletes to Korea for training before March next year. Alternatively, sending experts to the Brisbane Taekwondo Training Centre is being considered.

Olympic 2024 Qualification Tournament Venue

- The venue for the Olympic 2024 Qualification Tournament is planned to be the current dining hall. Installing partitions to create one court should be sufficient.

Transportation and Accommodation

- Cooperation with the GOC is essential for well-prepared transportation. Athlete accommodations should be close to the venue, with designated hotels for the headquarters and athletes. Referees and teams should not stay together.

Meals Planning

- Breakfast will be provided at the hotel, lunch at the venue, and dinner can be chosen between the hotel and the venue. Advance requests for meals should be collected through application forms. Meals for TD and referees should be arranged at the venue during the competition.

Technical Manual Sharing

- WT will soon share the Technical Manual with SOL NOC.

Roles and Responsibilities

- SOL MNA will focus on technical matters, while NOC will handle logistics. SOL NOC should also be involved in the joint training camp in January 2024.

Inclusion in School Curriculum

- If SOL NOC proceeds with adopting taekwondo into the school curriculum, WT is willing to assist by sending experts to train local teachers.

Brisbane Taekwondo Training Centre

- The Brisbane Taekwondo Training Centre, established in Australia, aims to be accessible to teams from Pacific Island nations. It plans to open in January 2024, allowing Oceania athletes to train at any time. The sports facility for revenue generation will operate separately.

Challenges Faced by Pacific Island Nations:

- Pacific Island nations like Tonga, Solomon Islands, and Kiribati lack facilities and coaches, presenting challenging conditions. Considering coach deployment, the local salary standard is approximately \$6,000. However, the key concern is ensuring the sustainability of coaching support.

Visa Challenges and Time Constraints

- Athletes from Tonga face significant challenges in obtaining visas for international competitions, with a processing time exceeding two months, creating substantial difficulties.

Government Initiatives in Tonga

- The Tongan government is actively working to improve the environment for women exposed to violence, utilizing sports as a catalyst for positive change. Taekwondo is identified as a leading sport in this endeavour.



# 3. Summary and Recommendation

The island nations of the South Pacific face significant challenges in terms of geographical accessibility, resulting in overall poor conditions for training facilities, equipment, and instructors. A common requirement among these nations is the dispatch of professional instructors to cultivate a sustainable local workforce. However, the unfavourable geographical conditions and challenging environment have made it difficult to attract applicants for an extended period. These nations express a desire to revive the past dispatch programs supported by the South Korean government. World Taekwondo (WT) intends to engage in discussions with relevant organizations to explore possible solutions.

As an initial step, WT proposes to dispatch experts to the Solomon Islands for a short-term period to conduct joint training with the Kiribati team in preparation for the Olympic 2024 Qualification Tournament scheduled for April next year. The training venue, accommodations, and other specifics have been identified locally, with detailed matters to be discussed in ongoing consultations.

Moreover, targeting the Kiribati National Championships in July next year, WT plans to support the installation of Protector Scoring Systems (PSS) and other equipment in advance, ensuring a smooth local competition. Continuous assessment and exploration of local needs for sustained support and development strategies are in progress.

Due to the practical challenges of dispatching experts for the Tonga team, consideration is given to inviting the team to Korea for a short, intensive training period.

Based on the above considerations, WT could select the following support projects for South Pacific Member National Associations (MNA):

- 1. Dispatch of experts for local training and joint training organization.
- 2. Invitation of local teams to Korea and the Brisbane Training Centre in Australia for concentrated training.
- 3. Support local competitions by providing equipment (PSS and other necessary gear) for competition-level upgrades.

Additionally, exploring additional support measures for projects aiming to include Taekwondo in school curricula in some countries is deemed necessary.
