IV. 2016 WTF Anti-Doping **Main Activities**

Selection of the 2016 WTF Registered Testing Pool (RTP) & Criteria:

- A) No. of athletes in RTP: 14 (7 male and 7 female). The number of the athletes is less than 2015 RTP List in order to make intelligent tests and increase the number of OOCT to be on line with WADA parameters. For the first time Para-Taekwondo Athletes was included for a better preparation of 2020 Olympics and for involve much more people in the fight against doping.
- B) Top 3 Athletes of the WTF Olympic Ranking & Top 1 athletes from the 2015 Para-Taekwondo World Ranking in the K44 class (3 male and 3 female weight divisions) was selected in order to control and educate the highest level of international athletes.
- C) Continental allocation balance was considered.
- D) Gender balance was considered

2016 WADA Symposium (March 14-16, 2016 / Palais de Beaulieu, Lausanne, Switzerland)

As partnership and quality practice under the 2015 World Anti-Doping Code (Code) are essential to mounting a successful collaborative campaign for clean sport, the Symposium was centered on the theme 'Partnering for Quality Practice' and, ultimately, focused delegates on the clean athlete and the ways and means of protecting their right to clean sport.

"In this year of heightened global interest in anti-doping, WADA's Symposium provided the Agency and its partners with the perfect opportunity to sit down under one roof and reflect on recent developments; exchange on challenges and opportunities; share best practices; and, generally, take stock regarding how we're delivering on our common, global, purpose to protect clean sport" said Frédéric Donzé, WADA's European Regional Office and IF Relations Director, who organized and hosted the event.



During his keynote address, Sir Craig Reedie, WADA President said, "In light of recent events, it is clear that WADA, and the anti-doping community, is facing a pivotal moment in its short history. The public's confidence has been shattered and it is up to us, the anti-doping community, to right the wrongs and turn this period of adversity into opportunity." In concluding his address, Reedie added: "Sport has had its wakeup call and the anti-doping community must find some of the answers to the questions posed today if we are to shore up trust, and give sport back its credibility".

The Symposium included a mix of plenary sessions under the sub-themes: how the 2015 Anti-Doping Code

is making a difference; how to capitalize on major events to protect clean athletes; how science can support quality programs; and anti-doping coordination. The last day offered up practical workshops related to: education; testing strategies; results management; sample storage and re-analysis; and doping reporting mechanisms. The event also featured interviews with Richard W. Pound, WADA's founding President and Chair of its Independent Commission that investigated and reported upon allegations into doping in Russian athletics; and, Lord Sebastien Coe, President of the International Association of Athletics Federations, who discussed his personal story and gave his take regarding anti-doping in light of the Commission's revelations.





WADA Basic Training Course on Information Gathering and Intelligence Sharing:

(March 17-18, 2016 / Palais de Beaulieu, Lausanne, Switzerland)

The meeting was held under the umbrella of WADA, in order to improve train the representatives of different international federations to investigate and collect information in cases of suspecting or discovering cases of doping in sport. The main concern was not medical, it was about how to suspect, investigate, follow up and collect proofs for the cases in your sport.

Main objectives of the training:

- Help Anti-Doping Organizations (ADOs) and international federations members to collect and manage information in an efficient way
- Train international federations members selected to create a network of "Intelligence Managers" after arranging with ADOs.
- Standardize the process to raise the level regarding information gathering and sharing

•

Training in the first day was about how to collect data and start forming a map for doping in each sport, this helps the federation to clearly suspect some people and some countries where doping seems to be a trend.

Learning outcomes of day 1:

- Intelligence and information: explanation and definition
- How intelligence is produced: the intelligence circle
- Different types of intelligence
- Examples of good intelligence
- How to interview a player or a coach.

Training in the second day was mainly concerned with analysis of the collected data and tracking all possible partners in doping administration. How to be effective and make good interpretations in case you become a member in hearing sessions.

Learning outcomes of day 2:

- Analysis (definition, purposes, sequence of analysis)
- Types of logic
- International Standards for Testing and Investigations
- Effective testing program: the successive steps: Risk Assessment
- Prepare interview questions.



Personal comments on the meeting:

It was very strong training to understand the doping plans that is implemented in sport, and how is it applied. It is also very good in explaining what kind of players we should suspect, target and follow up.

Recommendations:

- 1- The WTF may start forming a fixed team for investigating and following up the cases of doping in Taekwondo.
- 2- Hearing panel should be fixed and regular training should be given to the to standardize the process
- 3- Annual analysis of the doping cases to specify the high probability groups and countries in doping and make a frequent program for testing in and out of competition.

2016 WTF-WADA Partnership to Quality Meeting (June 1-2, 2016 / WADA office, Lausanne, Switzerland)

Event:

The Workshop was held in June Conference Room of Maison du Sport, Lausanne, Switzerland. The Workshop took place over two full days: June 1 and 2, 2016.

Key Themes:

Following the revision of ADOs' anti-doping rules and the implementation of these rules by ADOs in 2014 and 2015, one of WADA's priorities from 2016 onwards will be to monitor and assess the compliance of



ADOs' anti-doping programs and practices with the Code.

WADA's Executive Committee and Foundation Board have given a clear mandate, at their latest meeting on 17-18 November 2015, to implement a robust Code compliance monitoring process. This will ensure that quality anti-doping programs are in place in all sports and countries for the protection of clean athletes. While the formal Code compliance assessment process will not start until late in the second half of 2016,

While the formal Code compliance assessment process will not start until late in the second half of 2016, WADA support all International Federations (IFs) to reach or maintain Code compliance by offering to participate in WADA's "Partnership to Quality" project in the first part of 2016.

This partnership project involves an initial exchange of information and documentation between WADA and Ifs.

Followed by a two-day meetings between IF and a small team of WADA experts, to discuss and review IF anti-doping programs with IF's anti-doping personnel and experts.

Objectives:

The project is intended to identify any areas where enhancements can be made to meet the requirements of the Code and International Standards.

Following this site visit, the WADA team will provide WTF with a report including its observations and potential corrective actions to meet the requirements of the Code, International Standards and industry good practices. WADA will also follow up with WTF.

to assist in putting in place an action plan to address any recommendations made or corrective actions suggested and to provide the necessary support and guidance to achieve these. WTF believe this is a very useful first step towards compliance with the 2015 Code.

ANTI DOPING SERVICE AGREEMENT (WTF-DFSU)

Objectives:

After a WADA report on PTQ Meeting, WTF Anti-Doping Coordinator made a short term strategy in order to maintain WTF CODE Compliance making a contract with DFSU (SportAccord, Doping Free Sport Unit) focused on OOCT plan before Rio 2016 Olympic Games.

Whereas:

- A. DFSU's mission includes the development of specific services for International Federations (hereinafter the "IFs") and providing IFs and Event organizers with assistance, training and support in the field of anti-doping;
- B. DFSU will provide anti-doping services to WTF under the terms and conditions of this Agreement;
- C. WTF is the world governing body for the sport of Taekwondo;
- D. WTF wishes to outsource the administration of its anti-doping programme and avail itself of the services of the DFSU under the terms and conditions of this Agreement.



Description of the Services:

1. Out-of-Competition Testing

- Check the whereabouts of the Athlete
- Contact the Sample Collection Authority (SCA) with a testing request
- Evaluation of the best price vs. quality option available for testing in a specified location
- Selection of the SCA to be appointed for the testing mission
- Creation of the mission order in the Anti-Doping Administration and Management System (ADAMS)
- Preparation of the documentation package for those SCA which do not use ADAMS
- Transmission of the updated whereabouts before the test to those SCA which do not use ADAMS
- Verification that the test is performed within the deadline given to SCA
- Receipt of a copy/original of the Doping Control Form (DCF) and verification that the information is in ADAMS
- Recording and upload of the DCF information into ADAMS (if not yet done by SCA)
- Follow up with SCA to receive originals of the DCF (**if applicable**)
- Verification that the laboratory uploaded the analyses results into ADAMS and that the laboratory results are matched
- Follow-up with the laboratory if analysis results are not in ADAMS, contact laboratory for information (if applicable)

2. Invoicing:

- Reception of invoices from external 3rd parties
- Verification of the invoice (matching with Mission Order, Sample codes, Results Management authority)
- Follow up with external parties if any invoices are missing
- Registration of the invoice in the database
- Payment of the invoices
- **If applicable**: follow up with parties if banking details are missing or incorrect, contact the external parties
- Preparation of the invoices package (copies of any invoices) to be paid by International Federations (twice per year usually)
- Transmission of the invoice to the relevant person of the International Federation (before invoicing an IF check that all the information registered in our database is correct)
- Follow up with the IF on any questions regarding the billing
- Follow up if the bills are not paid within the deadline (reminder are sent to the IF)

Review on participation of Russian athletes in 2016 ROG

After the publication of McLaren report, IOC decided not to accept any entry of any Russian athlete unless such athlete can meet all of the conditions of the EB's decision. One of the conditions is that:



"The IFs should carry out an individual analysis of each athlete's anti-doping record, taking into account only reliable adequate international tests, and the specificities of the athlete's sport and its rules, in order to ensure a level playing field.

The IF should confirm the number of international tests that considers fair for the IOC Executive Board to accept for each sport in this regard. For consistency between sports, the IOC has determined that the international tests must have been conducted between 1 January 2015 and the opening of the Rio 2016 Olympic Village on 24 July 2016. In addition, the IOC confirms that:

The international tests must have been conducted by an independent accredited agency and the samples analysed in a WADA accredited laboratory.

Both in-competition (ICT) and out-of-competition (OOC) testing will be considered.

No testing will be considered if conducted in Russia prior to the establishment on 16 February 2016 of UK Anti-Doping Agency supervision of sample collection and sample analysis by a WADA accredited laboratory (outside of Russia).

Multiple tests conducted in a single day on an individual athlete (e.g. separate tests for urine and blood) will be considered as a single test.

The decision of the Executive Board on 24 July 2016 was on the basis that if an entry of a Russian athlete is not accepted by the Executive Board, the Russian Olympic Committee will not be permitted to enter a replacement except in the team sports of Handball, Volleyball and Water Polo."

Outcome of the investigation:

The 3 Russian athletes qualified for Rio 2016 Olympic Games are not implicated in the last doping scandal reported by Mr. McLaren and they have never been sanctioned for any ADRV. For this reasons WTF declare them eligible for the Rio 2016 Olympic Games.



Educational Activities during the 2016 WTF World Taekwondo Junior Championships

Anti-Doping Educational Booth in collaboration with CCES & WADA (Nov 13-15, 2016 / Burnaby, Canada)

During the WTF World Junior Championships, held in Burnaby, Canada, in November 2016, two separate information programs were run: One for athletes, and one for Member National Associations, or MNAs.

An outreach program for athletes, coaches and related parties was run by the Canadian Center for Ethics in Sport, or CCES. A booth was established at the training venue for two days, and then at the competition venue for a further two days. At the booth, visitors could take informational quizzes and respond to questionnaires, in return for fun handouts, such as a urine sample bottle emblazoned with the legend "#pee is gold." Other 100 athletes visited the booth.



"This is the prime age for athletes," said Jason Francis of CCES. "They are now becoming aware of the different supplements and different information out there, so to be able to get them the right information at this age is very important so that they can make informed decisions going forward."

The second program that ran alongside the championships was a seminar for all WTF MNAs in attendance, run by the World Antidoping Agency, or WADA.

The WADA seminar covered the latest developments in anti-doping, and the changing requirements of the code. 2015 was a "year of adjustment," 2016 was a "year of implementation" with WADA helping





International Federations to comply with the code; and 2017 will be a year in which changes are "mandatory," the MNAs were told.

"There is a need in the new code for an increase in education," said WADA Standards & Harmonization Manager Ilaria Baudo. "These junior championships are the perfect opportunity: Educate your athletes at the young level."

The WTF's first educational programs for athletes took place during the 2011 World Taekwondo Championships in Gyeongju, Korea, but until Burnaby in 2016, that campaign, and subsequent campaigns, were only for seniors.

TDSSA Implementation:

The Technical Document for Sport Specific Analysis (TDSSA) came into effect on 1 January 2015. The TDSSA is a level 2 mandatory document which is referenced in Article 5.4.1 of the 2015 World Anti-Doping Code. The aim of the TDSSA is to ensure that the prohibited substances within its scope are subject to a minimum and consistent level of analysis by all Anti-Doping Organizations (ADOs) conducting testing in certain sports/disciplines.

The year 2015 is considered a TDSSA implementation year rather than a year of strict compliance. This has provided ADOs with the time to adopt, implement and review the implementation of the TDSSA, within their testing programs and to put the necessary measures in place to ensure they are in a position to meet the minimum levels of analysis of the TDSSA in 2016.


WTF in 2016 worked with MNAs and Sportaccord in order to ensure a minimum level of TDSSA in the overall testing plan. Monitoring, planning and management of TDSSA were done by WTF that provides also extra funds to event's organizers to assist them with its application.

Implementation of the TDSSA in 2016 is a mandatory requirement and has been closely monitored from a compliance perspective from WADA.

2016 WTF-WADA Partnership to Quality Follow-up Meeting (Nov 15-17, 2016 / Lausanne, Switzerland)

After June meetings WADA made is final report containing the Outcome and recommendations for assist WTF with WADA's compliance assessment program that will be rolled out to all signatories in early 2017. During this meeting WADA coordinated with WTF Anti-Doping Coordinator the action plan which should be completed and provided to WADA's IF Relations staff based in the Lausanne office, who will be responsible for providing further assistance to the WTF on the outcomes of the report.





WTF Member National Federations 2016 Survey (Anti-Doping part)

WTF Anti-Doping Coordinator developed a list of questions to be added into the MNA survey in order to monitor MNA Anti-Doping activities and use the survey as Anti-Doping intelligence for future regional and national level management:

Questions:

- 50. Do you conduct anti-doping education for your athletes and/or athletes support personnel?
- 51. If yes, what type of education activities does your education program include?
- 52. Do you conduct no advance notice out-of-competition (OOC) anti-doping testing in coordination with your NOC, NADO, or another national organization?
- 53. If yes, how many urine and/or blood samples do you collect OOC per year?
- 54. What is the level of athletes you test OOC?
- 55. Do you conduct in competition (IC) testing at national level events?
- 56. If yes, how many IC urine and/or tests do you collect per year?
- 57. Do you use a WADA accredited laboratory/ies to analyze all anti-doping samples you collect?
- 58. How many Therapeutic Use Exemption (TUE) applications do you receive per year?

COMMENT: The above information is intended to help the WTF to implement an effective anti-doping program that maximizes the probability of both detection and deterrence, as required by the World Anti-Doping Code and the International Standard for Testing & Investigation (ISTI)

V. Para Taekwondo Activities (November 2016 - May 2017)

General Overview

The Para Taekwondo department has been working in line with the 2015-2020 Para Taekwondo Strategic Plan and with relevant committees to develop and spread the practice of Para Taekwondo among the WTF member national associations. The department has consisted of one Manager and one Coordinator. Since March 2017 only the Manager has been working and the process of hiring a new Para Taekwondo Coordinator is in progress.

Para Taekwondo Kyoruqi

In November 2016 the WTF General Assembly passed new Para Taekwondo Competition Rules. With the upcoming Tokyo Paralympic Games it was necessary to establish Para Taekwondo Competition Rules in a separate document. The rules came into effect January 1, 2017 and has been evaluated at several events that has led to the amendment proposals put forward to the General Assembly in this agenda.

The Para Taekwondo World Ranking is a great measurement of the development of Para Taekwondo Kyorugi. Since the last report to the General Assembly in November last year the World Ranking has developed from 226 athletes (176 male and 50 female) from 47 countries to contain 261 athletes (203 male and 58 female) from 58 countries as of May 1, 2017. This is a great development and it should be noted that since the end of 2015 the number of female athletes ranked has more than doubled.

With the new Competition Rules that came into effect January 1, 2017 the need for education of International Referees in Para Taekwondo Kyorugi has become evident. Rules on administration of IRs in Para Taekwondo Kyorugi has been put forward to the WTF Council and education programs are being developed. The aim is that in 2018 licencing of International Referees in Para Taekwondo Kyorugi will start. A great thank you to the Para Taekwondo Referee Committee and its Chairman Mr. Chakir Chelbat for their work in developing these rules.

Para Taekwondo Poomsae

Para Taekwondo Poomsae Competition Rules were passed by the General Assembly in November 2016. The rules have been tried out at the 2017 US Open Para Taekwondo with good feedback from Referees, Coaches and Athletes. Continuous evaluation will be made during events in 2017. The Para Taekwondo Poomsae Committee and its Chairman Mr. Tong Wan Shin, has done a great job in establishing the Rules. 2017 will also be the year that WTF introduces Para Taekwondo World Ranking in the P20 Sport Class for Intellectually Impaired athletes. The fist competition awarding ranking points will be the 2017 Austria Para Taekwondo Poomsae Open (G1).

The Committee has also worked on establishing rules for International Referees in Para Taekwondo Poomsae that was deliberated by the WTF Council at their last meeting. An IR course to evaluate the course material was held in Austria on the occasion of the Austria Para Taekwondo Poomsae Open. The first IR Seminars in Para Taekwondo Poomsae will be held later on in 2017.

Para Taekwondo Poomsae is included on the 2018 CPISRA World Games (P30 Sport Classes) for athletes with a motor impairment and the 2019 INAS Global Games (P20) for athletes with an Intellectual Impairment. The INAS Global Games will be held in Brisbane, Australia.



Athlete Classification

The WTF Athlete Classification Rules are currently being redrafted by the Classification Committee to be compliant with the new IPC 2015 Classification Code. These rules will be presented to the General Assembly in the form of an e-vote later on in 2017.

The WTF Research Committee together with the Classification Committee is working on an research project for Para Taekwondo that will be ongoing for the period 2017-2020.

Education

The Para Taekwondo Education Committee has been working on the first online module for Para Taekwondo Education "Introduction to Para Taekwondo" that is set to go live in 2017.

Paralympic Games

The WTF has presented draft "Standing procedures for the Paralympic Games" to the IPC. These rules are currently being evaluated by the IPC and are expected to be finalized following the IPC Governing Board's decision on the quota and medal event allocation for Para Taekwondo at the 2020 Tokyo Paralympic Games program. This decision will be made during the IPC Governing Board meeting in Abu Dhabi September 3-4, 2017.

WTF has made an application for 9 medal events (6 male and 3 female) and 72 athletes (48 male and 24 female) to the IPC. Accordingly, not all Sport Classes will be represented on the 2020 Tokyo Paralympic Games program.

1) SportAccord Convention

• WTF delegates attended the SportAccord Convention held in Aarhus, Denmark from April 1st to 7th. The WTF delegates held more than 20 fruitful meetings with city governments, venues, tourism bureaus, companies to discuss future collaboration on staging the WTF events. Especially during the convention, Head of Event Department attended the City Forum as a panelist and impressed audiences with the innovative bid and event management system of the WTF.

Partnership Workshop (Lausanne, Switzerland)

43 people from city governments, tourism boards, MNAs and agencies gathered to learn about the WTF's renewed bid process and the systematic event management system. Mr. Mattias Kaestner, IOC Head of Candidature Services, and Mr. Andrew Ryan, ASOIF Executive Director, also attended the Workshop and delivered their presentations and praised the WTF's innovative approach.

3) Expand the client base

More than 1,130 email contacts have been collected from "SportAccord Convention",
 "Sportcal.com", "Convention & Visitors' Bureau Directory", etc. To these potential clients,
 the WTF sends out useful information on their bidding interests in the WTF events.

4. Renewal of bid & event management system

- 1) Development of the WTF Events Bid Manual
 - The WTF developed the WTF Events Bid Manual as a comprehensive guidebook for all parties interested in hosting the WTF events. This Manual provides overall information of all the WTF-promoted events and how to make successful bids for the events. Notably, the Operational Requirements and the sample Host City Contract are attached to the Manual. This highlights the WTF's pursuit of transparent bidding process and maximized communications with potential hosts.

2) Introduction of Operational Manual and Operational Plan

Former Technical Manual is now reformed and provided to LOCs as the Operational Manual. Comprised of nine functional areas including competition, venue, stakeholder services, etc., the Operational Manual is designed to help LOCs to clearly understand operational requirements and ways to organize cost-effective and value-sharing WTF events. In addition, the Manual now includes the Operational Plan. LOCs will draw up their own plans for successful event delivery on the Operational Plan and submit to the WTF. These Plans will serve as an effective communication material which enables seamless preparation for every functional area.



- 3) Amended Rules on Organization and Operation of International Taekwondo Championships
 - Former Rules on Organization and Operation of International Taekwondo Championships are now called WTF Event Operations Rules. In the Rules, renewed bidding process is applied.
 Format of the Rules has been also changed so anyone who needs to be advised by the Rules can find the parts they look for easily.

5. Olympic Event Modification

1) The WTF has submitted to the IOC Sports Department two applications for adding the Freestyle Poomsae Pair event and the Mixed Team Kyorugi event to the Olympics. With in-depth understanding of the competing International Federations and the directions of the IOC, the applications were composed under two strategic pillars. First one was gender equality and the other one youth appeal. These are the futuristic requirements of the IOC to all the Olympic Sports.



VII. TV Activities (May 2015 – May 2017)

This is the summary of the activities of the TV Department since the General Assembly held in Chelyabinsk, Russia in May 2015. Multi-dimensional activities have been put in place to improve the quality of production by providing standard production guideline and pre-event and onsite consulting, ensure consistency in look of TV graphics by providing graphic package for each event and offer a better service to international broadcasters for the sake of increasing exposure of taekwondo events on the TV and major media channels and platforms.

As a result, the process of production of international feed has been standardized, and the synergy in cooperation the host broadcast appointed by the organizing committee of each event has increased. Furthermore, more and more broadcasters showed taekwondo events in their countries in different forms, such as live or delay, highlight, news or special features around the world.

For example, 2015 World Championships has been distributed in 112 countries and each of Grand Prix event has been distributed in more than 80 countries.

The Asia Broadcast Union (ABU) complimented during the 2016 ABU Sports Conference held in October 2016 that Taekwondo is one of the most successful sports which have been distributed in most number of its member broadcasters.

To build on the moment, for the cycle of 2017 -2020, the WTF has renewed the partnership with the ABU and Spring Media for the distribution of the media license and have successfully concluded license deals with key stakeholders.







1. WTF recognition of taekwondo competition products

The WTF has granted its recognition to products like uniforms for Kyorugi and Poomsae competitions, head protector/mask head protector, trunk protector, PSS (protector & scoring system consisting of electronic trunk and head protectors and sensing socks), hand protector, forearm guards, shin guards, groin guard, mat and Poomsae scoring system, based on the WTF Competition Rules and Poomsae Competition Rules under recognition agreement with sport equipment companies.

1. Renewal of recognition agreement

- A. 2015 recognition agreements due to terminate on Jan. 30, 2016 were renewed. One company was newly recognized.
- B. Introduction of 4-year recognition (2017-2020);
 - B.1 4-year recognition system based on the Olympic cycle:
 - B.2 The idea of introducing WTF plan for 2017-2020 4-year recognition system was first explained to existing recognized companies at the WTT-recognized companies Workshop held in WTF Seoul office on Feb. 12, 2016 and the companies agreed.
 - B.3 4-year recognition system for 2017-2020 with recognition fee discount system and with the strengthened company benefits based on the categorization of all recognized companies was approved by the WTF Council at its meeting in Muju, Korea on May 6, 2016 and was announced to existing recognized companies. Details of the 2017-2020 WTF recognition system except the recognition fee per product item was posted on the WTF website.
 - B.4 Projected time frame of the 2017-2020 recognition system:

1. Finalization of 2017-2020 recognition agreement

Four-year recognition system based on the Olympic cycle was introduced and 4-year recognition agreement for 2017-2020 was signed with 15 out of total 16 companies. One company signed one-year agreement for 2017, expressing it will renew the agreement every year.

Under the 4-year recognition system, recognized companies are classified into three categories based on the amount of annual recognition fee with top 25% as A, middle 50% as B and bottom 25% as C. In addition to existing services for the WTF-recognized companies, the benefits to recognized companies were strengthened as below:

- Recognition fee discount: 15% recognition fee discount in the third year (2019) and 25% recognition fee discount in the fourth year (2020), making the average 10% discount of recognition fees for four years.
- Increased exposure of recognized brands: on WTF website and WTF Seoul headquarters
- Invitation to WTF-promoted events (GP Final & WTF Gala Awards) to A-category companies
- Free or discounted advertisements on WTF annual magazine (from 2018 magazine) for A-category companies
- Free or discounted booth at World Taekwondo Championships and/or World Taekwondo Junior Championships for A-category companies

XII. Taekwondo Cares Activities

(December 2016 - May 2017)

1. Nepal Earthquake Relief Project (March 25, 2016 – May 14, 2016)

In April 25, 2015 a devastating 7.8 magnitude earthquake struck Nepal and more than 8,600 people lost their lives, over 16,000 were injured, more than 2.8 million people were displaced and in need to humanitarian assistance. With such critical situation of Nepal, the WTF decided to help people in Nepal with taekwondo, which is the best way the WTF can help out people in need of physical and mental help.

The programs were held in 9 different districts. Qualified instructors from the WTF taught taekwondo to 11 senior local instructors and 390 children and related educational programs in refugee and displaced persons and the WTF supported necessary equipment, materials and infrastructure.

2. Jordan Taekwondo Academy Project (20 April, 2016 – Present)

In line with the IOC's Olympic Agenda 2020 and the UN's Agenda 2030 Sustainable Development, the WTF has taken its social responsibility seriously. The WTF empowers refugees and displaced persons in Jordan by training them in the sport and martial art of taekwondo.

At the Azraq Syrian refugee camp in Jordan, a Korean coach and a local instructor were dispatched for taekwondo classes for 29 male students aged 11-14 in April 2016. Another class for 23 female students began in July 2016.

3. Nepal Taekwondo Cares Project (March 1, 2017 – December 1, 2017)

Since the Nepal Earthquake Relief Project ended successfully, the WTF was keenly interested to carry out taekwondo training for the orphan children from Nepal as physical activities which helps for their character building process.

With the motto of 'Let's build the future with Taekwondo' the WTF supported Nepal Taekwondo Association to carry out 10 months long Taekwondo training program named 'Taekwondo Cares Nepal' for orphan children with full support of the Hana Nanum Foundation.

A total of 248 children from 8 different organizations have been included for the training program.

4. The Hope Schools Project

The Korean Olympic broadcaster SBS has established schools in twenty African countries. A title of this project is the Hope School. The WTF and the SBS had several meeting and as a result, the WTF has decided to operate taekwondo classes in collaboration with the Hope Schools.



So far, the Rwanda and Niger MNAs agreed with operating taekwondo classes in their respective territories.

5. Austrias Awards Project

The Princess of Asturias Awards are a series of annual prizes awarded in Spain by the Princess of Asturias Foundation to individuals, entities or organizations around the world who make notable achievements in the sciences, humanities, and public affairs.

Since taekwondo is now an international martial art practiced in 208 countries and the WTF is at the forefront of the international campaign to support refugees living in developing countries, the WTF is qualified to apply for the sport category of the awards.

The WTF had submitted application to the Austrias Awards and the result of awards will be disclosed in 2017.

6. Celebration of the Day of Sport Project (28 March, 2017)

In accordance with the partnership agreement between the THF and Peace & Sport, as the operational partner of THF, the WTF was offered an opportunity to join the activities of Peace & Sport in celebration of the International Day of Sport for Development and Peace.

The event was jointly organized by the Permanent Mission of Monaco to the United Nations together with the international organization Peace and Sport within the framework of the 4th edition of the international Day of Sport for Development and Peace, celebrated on April 6.

During the event, the US national poomsae team athletes performed freestyle poomsae performance and a kyorugi match took place between two of the finest athletes, Great Britain's double Olympic gold medalist Jade Jones, and World Taekwondo Junior Championships' gold medalist Skylar Park from Canada.
